It is hereby informed that the following provisions of CPRMSE are amended with immediate effect in line with CIL.

5.4	<p>All the retired Executives and/ or Spouse will have to submit a "Life certificate" In the revised format every year in the month of November.</p> <p>The Life certificate may be issued by any one of the following persons:</p> <ol style="list-style-type: none">The Branch Manager of the Bank where the concerned retired executive and/or spouse is maintaining the single-owned Savings Bank Account.A Gazetted Officer of Central Government or State Government.A registered Medical Practitioner.Any Officer of the Company (duly indicating designation and Seal)	<p>All the retired Executives and/ or Spouse will have to submit a "Life Certificate" In the revised format every year in the month of November.</p> <p>The Life certificate may be issued by any one of the following persons:</p> <ol style="list-style-type: none">The Branch Manager of the Bank where the concerned retired executive and/or spouse is maintaining the single-owned Savings Bank Account.A Gazetted Officer of Central Government or State Government.A registered Medical Practitioner.Any Officer of the Company (duly indicating designation and Seal)The Jeevan Pramaan Certificate / Digital Life Certificate of Concerned Executive and Spouse or the survivor beneficiary (in case of single beneficiary) can be submitted from any Citizen Service Centre / Government Offices .

Clause No	Existing Provision	Amended Provision
5.5	The Medical card will be revalidated on yearly basis on submission of 'Life Certificate'. Non-submission of 'Life certificate' will make the medical card invalid.	Medical card issued will be revalidated on yearly basis on submission of either " <u>Life Certificate</u> " or " <u>Digital Life Certificate</u> ". Non submission of "Life Certificate" / "Digital Life Certificate" will make the medical card invalid.

Hence wide publicity may be given advising the beneficiaries of CPRMS-E (Exited Executives and or spouse for whom Medical card was issued) to submit their duly-filled-in Life certificates in the prescribed format in the month of November 2022 , either in hard copy or by E-mail (cprmse@scclmines.com) to CPRMS Cell at Main Hospital, Kothagudem or through online generation of Jeevan Pramaan Certificate/ Digital Life Certificate in order to ensure the revalidation of their Medical cards as per scheme guidelines.

Further the updation of Life Certificate in master data under CPRMSE shall be carried out by the Incharge-CPRMS Cell at Main Hospital, Kothagudem, in accordance with Circular No: CRP/PER/C/2022/848 dt:01.03.2022

The other terms and conditions of the scheme remains unaltered.
