The Singareni Collieries Company Limited, here in after referred to as Company having
its registered office at Kothagudem, Bhadradi Kothagudem Dt, Telangana, of the 3rd part

of his own free will and with the consent of his surety has agreed to receive the Trade
apprenticeship training imparted by the company, it is agreed as under:

- 1 I will undergo apprenticeship provided by the Company for a period of one year
- 2 That the Company shall pay the stipend during the training period with liberty to stop such
stipend and to recover Rs.**50,000/- or actual expenses** whichever is assessed by the
Company for any breach of Terms &Conditions conditions of Annexure-1 by the apprentice,
including that of suppression of facts/false certificates or wrong declaration.
- 3 Myself(Apprentice) and my surety shall compensate the SCCL for the actual Stipend plus
expenses incurred on account of and in connection with the training as assessed by the
Apprenticeship adviser as per the terms & conditions of the provisional offer.
- 4 That the surety hereby agrees to stand surety to the said Apprentice to compensate the
Company due to the Non-performance or non-compliance by the Apprentice as per the terms
and conditions specified in Annexure-I, the surety hereby further agreed that no indulgence
shown or concession granted to the Apprentice shall have the effect or discharging the said
surety or shall effect his liability arising out of this agreement to any extend whatsoever.
