

NOTICE FOR THE SCCL-POST RETIREMENT MEDICARE BENEFICIARIES



This is for information of all beneficiaries under CPRMSE of The Singareni Collieries Company Limited availing the post-retirement medical benefit from SCCL that they are to submit the Life Certificate in **NOVEMBER 2022** to re-validate their CPRMSE Card.

In case of Digital Life Certificate, there is no need for sending physical copy

Offline/ Hard copy submission of Life Certificate Form

CPRMSE beneficiaries can submit the paper-based Life Certificate

- either physically to SCCL at O/o Chief Medical Officer at Main Hospital or
- by mailing the scanned copy of the duly attested, duly filled Life Certificate to the respective email address. Email ID is cprmse@scclmines.com, the Life certificate pro-forma can be downloaded at <https://scclmines.com/scclnew/ExEmp.asp?cir=2911201900.PDF>

NOTE:

- The Life Certificate has to be submitted in revised format, which is also available in the above link.

Online submission – Digital Life Certificate / Jeevan Pramaan

The CPRMS beneficiaries can visit a nearby Citizen Service Centre, Bank Branch or any Government office whose details are provided on <https://jeevanpramaan.gov.in/locatecentre> and biometrically authenticate his / her life certificate in real time. SCCL will receive the Life Certificate automatically after biometric authentication and will be validated in-house after three working days.

NOTE:

- For couple membership cases, i.e. when both retired executive and his/her spouse are alive – 02 (two) separate Digital Life Certificates have to be generated.

For Pension (CMPF)

Pensioner needs to generate **one (1)** Jeevan Pramaan Certificate / Digital Life Certificate using Biometric Authentication or Face Authentication based on UIDAI Aadhaar Software;

- 1) Disbursing Agency: **SELECT CMPFO**
- 2) Sanctioning Authority: **Select CMPFO**
- 3) **Enter Your PPO Number**

FOR POST- RETIREMENT MEDICARE (CPRMSE)

CPRMS-E beneficiary needs to generate **Two (02)** Jeevan Pramaan Certificates / Digital Life Certificates using Biometric Authentication or Face Authentication based on UIDAI Aadhaar Software

- 1) Disbursing Agency: **SELECT The Singareni Collieries Company Limited**
- 2) Sanctioning Authority: **Select The Singareni Collieries Company Limited**
- 3) PPO Number: **Enter Medical Card No. followed by E or S** (For Employee “E” and for Spouse “S” as the case may be)

Eg: 1234E or 1234S

A retired executive of SCCL shall submit in total **03 (three)** Jeevan Pramaan Certificates.

One (01) Certificate for Pension

Two (02) Certificates for Post-Retirement Medicare Scheme i.e:

One for Self (i.e. retired executive)

Another for his/her Spouse

CMPF & CPRMSE HAVE TWO (02) DIFFERENT DISBURSING AGENCIES i.e. CMPFO & The SCCL
