CIRCULAR

Sub: CPRMSE – Change of option for payment of outpatient domiciliary treatment under clause no. 3.2.2 as well as availing medical facilities as dependant under Medical Attendance Rules to the retired executives - Reg.

Of late, several representations have been received from the retired executives to permit them to avail payment of domiciliary treatment amount @ Rs. 36,000/- per annum, in lieu of availing medicines in company hospitals. The President, CMOAI has also represented the same to consider the change of option of retired executives for payment of domiciliary treatment amount instead of availing the same in company hospitals.

Similarly, some of the retired executives whose spouses are working in our company are also requesting to allow them to avail CPRMSE benefits instead of treatment under Medical Attendance Rules as dependent as in CIL.

The above issues have been examined in detail and it has been decided as follows –

1. Change of option for domiciliary treatment –

The retired executives who have opted for domiciliary treatment in the company initially at the time of enrolment under the scheme are hereby allowed to change their option from availing medicines in company hospitals to receive payment of Rs. 36,000/- per annum under clause no. 3.2.2 and 3.2.3 - Outpatient / domiciliary treatment of the scheme.

Hence, all the retired executives, who wish to change their option, shall have to submit their option in writing to CPRMSE Cell, Corporate on or before 31/12/2020 to avail the facility of Outpatient / domiciliary treatment in lieu of availing medicines in the company hospitals. This shall be one-time measure and the options now given shall be final.

2. Issue of Medical Cards to retired executives whose spouses are working –

It has also been decided to allow option to the retired executives, whose spouses are working in SCCL, either to opt for CPRMSE Medical Card or to avail treatment under Medical Attendance Rules of the company.

The option once exercised shall be final and binding on the executives. If a retired executive opts for CPRMSE benefit under the Scheme, he / she shall be excluded for extending medical benefit as dependent of spouse under Medical Attendance Rules of the company.

In case the retired executive who is availing medical facility under Medical Attendance Rules as dependent of working spouse, his / her coverage will automatically come under CPRMSE on retirement of spouse subject to declaration that he / she has not been availing such facility in any other scheme.

This issues with the approval of the competent authority.
