CIL/C-5B/JBCCI//CPRMS-NE/212, In line with Office Memorandum No. dt.18.11.2021 issued by GM(MP&IR), extending opportunity for a period of 3 months from the date of issue of circular to eligible separated Non-Executive Cadre employees who have not vet become member of CPRMS-NE(Modified) to become member of CPRMS-NE(Modified), the Competent Authority has approved to extend opportunity to become member of CPRMS-NE(Modified) to all eligible separated Non-executive cadre employees who have not yet become member of CPRMS-NE(Modified) in accordance with the circulars referred above, for a period of 3 months from date of issue of this circular i.e. upto 22.03.2022. The above opportunity shall also be available to the members of CPRMS-NE circulated vide circular No. CRP/PER/IR/CPRMS/375, dt. 23.03.2018 who have not yet become member of CPRMS-NE(Modified) subject to fulfilling all other terms & conditions.

Accordingly, the following categories of NCWA employees who have not yet enrolled as members of CPRMS-NE(Modified) are extended one more opportunity to become members of CPRMS-NE(Modified) upto 22.03.2022.

(i) Non-executives who retired/separated before 01.07.2016 (i.e. prior to operation of 10<sup>th</sup> Wage agreement for CIL & SCCL) including members of CPRMS-NE (Old scheme), by depositing the balance or entire membership contribution, as applicable, totalling Rs.40,000/- for enrolment in CPRMS-NE(Modified) within the stipulated extended date of 22.03.2022 as the last chance. (ii) Non-executives who retired/separated during the operation of 10<sup>th</sup> Wage Agreement by depositing the balance or entire membership contribution for enrolment in CPRMS-NE(Modified) i.e. totalling Rs.40,000/- as applicable on or before 22.03.2022.

The interested eligible separated NCWA employees/spouse as mentioned above should submit their applications in the prescribed proforma circulated vide circular 3<sup>rd</sup> cited to the respective Head of the mine/dept., where he/she last worked along with a DD for the total prescribed amount of Rs.40,000/- in the case of Ex-employees who did not contribute any amount so far and in the cases of Ex-employees from whom partial contribution was recovered/remitted, the balance amount totalling Rs.40,000/- together with requisite documents **on or before 22.03.2022** for scrutiny of their applications for enrolment in CPRMS-NE(Modified).

The concerned Head of the mine/dept. shall thereafter process the applications of the eligible ex-employees as per the guidelines communicated vide letter 3<sup>rd</sup> cited.

Necessary action may please be taken accordingly.

Wide publicity may also be given regarding the contents of the circular.
