1	<b>The HPSV Flood Light Fitting shall be long range, high intensity luminance with lamp, Control gear (consisting of energy efficient ballast, ignitor, capacitor and fuse with duly wired connections)</b>
2	The Luminary shall be long range, high intensity, energy saving HPSV Flood Light, dust, moisture and vermin proof and shall have degree of protection IP-65. The luminary shall be complete with highly polished, mirror finish stainless steel reflector-cum-body, pilfer proof and captive bolting system incorporating vibration isolators, toughened front glass of minimum 5mm thickness, focusing arrangement, neoprene rubber gaskets & steel inserts at the threaded portion, G.S. lamp holders with lamp locking arrangement and M.S. cradle with passivated bolts. In addition to the firms standard guarantee terms, the stainless steel reflectors shall be guaranteed for an effective performance for a period of five years. In case of failure, free polishing / replacement is to be done to the reflector by the firm.
3	The luminary should be suitable for use with both tubular and elliptical lamps but would not in any way infringe with performance of the luminaries.

They should have been type tested with certification by manufacturer and shall be supplied separately for the luminaries. Copy of type test report including life test shall be submitted along with the offer.
