Specifications:

- 1. Strong polyester out shell, EPE foam padding.
- 2. 3 pieces of straps are fastened with buckles.
- 3. ISO12402-5 Standard.
- 4. Buoyancy: 50N,
- 5. CE approved according to EN393.
- 6. To work at sumps and connected activities.
- 7. High visible fabric.
- 8. Life jackets should have weight of less than 1kg.

12. Jackets should show no loss of buoyancy after immersion in water for 24 hours.

13. The materials used for covers, tapes and seams of the LIFE JACKETS should be tested at government approved laboratories to establish that they are Water proof. Color fast and resistant to deterioration from exposure to sunlight and are not unduly effected by sea water, Oil or fungal attack.

14. LIFE JACKETS should meet the strength –body strength and shoulder strength test Prescribed in sola.MSC 200(80) regulation, where in a load of 90 kgs is attached for a Period of 30minutes. 15. LIFE JACKETS should be fitted with approved Retro reflective Tapes 2"x4" at eleven strategic points for immediate visibility.

16. LIFE JACKETS should have tapes for fastening.

17. LIFE JACKETS should be capable of supporting a weight of 14.5 kgs for 24 hours without any effect on the lifebuoy.

18. LIFE JACKETS should show no deterioration after immersion in Diesel oil for 36 hours without any effect on the lifebuoy.

19. LIFE JACKETS should not sustain burring or continue melting after being totally enveloped in a fire for a period of 5 second.
