02. Sample Sanitizer bottles (100ml, 200ml, 250ml or 500ml) to be submitted separately along with offer with composition details sticker on bottle (only one sample to be submitted)
03. Composition of ALCOHOL/IPA/ETHANOL – must be 75% or above in Sanitizers.
04. The following documents/certificates to be submitted along with the technical bid.
 - a. Valid Drug License certificate (for manufacturing of Sanitizers) from Drugs Control Administration of Telangana State Govt.
 - b. Previous order copies for supply of sanitizers to any Govt. Organizations,
 - c. Recent Test reports from any approved/recognized Lab(like NABL) to confirm Antimicrobial activity of Sanitizers are more than 99.99%.

- iii. Not submitted Sample bottle (with composition)
- iv. Not submitted recent Test reports from any approved/recognized Lab(like NABL) to confirm Antimicrobial activity of Sanitizers are more than 99.99%.
- iv. If Delivery period not mentioned – not accepting to supply within three to four days
