In case the running bills amount is not sufficient, SCCL may give notice to pay the amount, the bidders shall pay the amount within 15 days of receipt of the notice, otherwise the amount will be recovered by invoking the Performance Bank Guarantee.

- A. LD Penalty clause:** In the event of supply not being effected within the contractual delivery schedule, liquidated damages @0.5% of basic price, not by way of penalty, of the value of the material per week of delay or part thereof subject to a maximum of 10% is recoverable from the supplier without prejudice to the rights of purchaser to procure the balance material at the risk and cost of the supplier. Should be able to select an image in a PDF and use the editing tool to crop, rotate, delete, or replace it. Edit PDFs with minimal effort from anywhere, on any device. With Acrobat, the user should be able to have instant access to the essential PDF tools needed across desktop, mobile devices and the web. Should provide features to easily edit, create, share, organize.

### **SW.1.6 Built in Tool to Compress Files.**
