## Common Specifications for the above Vehicles:

All the vehicles should incorporate the required features, as specified vide DGMS (Tech) Circular No. 06 of 2020, Dt.27.02.2020

The important features for LMVs are as follows:

- a) Seat belt and seat belt reminder
- b) Auto dipping system for head lights

<sup>\*</sup> The vehicle should be in the name of successful contractor

Note: i) The above mentioned quantities are tentative and may increase or decrease.

- ii) The contract period is 3 years and further extendable period is 1 year based on condition and performance of the vehicle. However, the extension is Solely at the discretion of SCCL.
- 3) **Model of the Vehicle**: First time registered after opening of the tender, the vehicle should be in the name of the successful contractor only.
- 4) Eligibility criteria.

Preference for awarding the contract will be given in the following order.

a) 1<sup>st</sup> Category :Project affected persons means project displaced persons and Land oustees come under 1<sup>st</sup> category and they will be treated equally.

Note: If 1<sup>st</sup> category persons are not available then 2<sup>nd</sup> category persons will be given opportunity.

b) **2**<sup>nd</sup> **Category**: Dependents of Ex-Employees of SCCL who are not provided job or Ex-Employees of SCCL come under 2<sup>nd</sup> category.

**Note:** If 2<sup>nd</sup> category persons are not available then 3<sup>rd</sup> category persons will be given opportunity.

c) 3<sup>rd</sup> Category: Others come under 3<sup>rd</sup> category

Persons falling under category 1 & 2 are permitted to deploy one vehicle per head only. Further, it is to inform that first preference will be given to YLD Area persons only. If no response is received within the Area, then the offers of the other Areas will be considered in the same order of eligibility criteria.

Project displaced persons and land oustees, ex-employees/dependents of ex-employees who have been allotted/already selected for deployment of vehicle at any Area of SCCL under unit rate system are not eligible for this Enquiry and the same is to be confirmed by the Applicants.

After completion of the tender process and placement of order, if it is found that the person is already allotted / selected for deployment of vehicle at any other Area of SCCL, the vehicle will be withdrawn immediately and EMD and Security Deposit and pending bills, if any, will be Forfeited.

- 5) If the Tenderer is a Project affected person / Project displaced person, his tender should accompany the following letter duly signed by the Tenderer with the following details.
  - a. Extent of land acquired
  - b. Survey No.
  - c. Village.
  - d. Mandal.
  - e. Award No & date .
  - f. Purpose for which it was acquired.
  - g. Certificate from the Govt. Authorities about his identity.

Therefore, the eligibility of Tenderer under the above Category is subject to verification of the genuineness of the details submitted by the Tenderer

6) In case of Dependents of Ex-employees of SCCL, who were not provided job or Exemployees of SCCL, they should submit any of the following document to the respective Personnel Department of SCCL of that Area.

### SCCL Identity card / Hospital Book SCCL Pay slip with Employee code No.

After submitting any of the above, they should get Certificate that he is dependent of Ex-employee of SCCL or Ex-employee of SCCL from that Area and submit the same to In-charge, personnel Dept., YLD Area, further, the In-charge, Personnel Department, YLD Area will forward the same to be enclosed to the application after due certification.

Without the above documents, the applications received cannot be considered for preference category.

- 7) In case the tenderer is Driver-cum-owner, he is required to submit the relevant Documents (valid driving license etc.,)
- 8) Draw will be conducted for number of firms equal to the number of vehicles.firms will be selected Additionally, a number of firms equal to twice the number of vehicles will also beselected in the lottery and will be kept as standby.
- 9) All the above firms which are selected in the lottery along with standby firms selected in lottery will be given lottery serial number and sent for technical evaluation
- 10) On confirming the technically and commercially acceptability the firms which are standing in lottery serial will be considered for the award of contract. Firms in the standby list will be considered for award of contract as per serial number in the lottery list on confirming their technically and comercially acceptability if any dropouts before their serial number. The standby list will be maintained for a period of 2(Two) years from the date of opening of concerned enquiry for future requirements of vehicles, if any.

#### 11) EMD & Security Deposit:

- a) For 2WD Non-AC Camper Jeeps, 2WD AC MUV & Non-AC Multi Utility Vehicles: EMD of Rs.7500/- (Rupees seven thousand five hundred only) per vehicle shall be submitted along with Tender and the successful tenderer shall deposit sum of Rs.5,000 /- (Rupees Five thousand only) per each vehicle as security deposit by way of DD with in two weeks from the date of commencement of work. Persons falling under 1<sup>st</sup> & 2<sup>nd</sup> category are exempted from submission of EMD.
- b) For 1.2 Ton Platform Truck with 2WD Non-AC: EMD of Rs.10,000/- (Rupees ten thousand only) per vehicle shall be submitted along with Tender and the successful tenderer shall deposit sum of Rs.5,000 /- (Rupees Five thousand only) per each vehicle as security deposit by way of DD within two weeks from the date of commencement of work. Persons falling under 1<sup>st</sup> & 2<sup>nd</sup> category are exempted from submission of EMD.
- 12) PROCESSING FEE (Non Refundable): An amount of Rs.590/- (Rupees Five Hundred and Ninety Only) Rs.500/- +Rs.90/- GST per tender schedule is to be paid by cash only, at the office of the General Manager, Yellandu. On submission of paid reciept, Tender Schedule can be obtained from SE(E&M), Purchase Department, O/o General Manager, (PO) Yellandu, Bhadradri Kothagudem District-507124 from 30.08.2023 on any working day between 10:00AM to 04:30PM.

c) Date of opening of Tender Documents : 20.09.2023 at 03:30 PM.

d) Date of Draw (Lottery ) : Will be intimated later.
