 If 2nd category persons are not available, then 3rd category persons will be given opportunity
- c) Others come under 3rd category

Note: First preference will be given to RG.I Area persons only. If no person is received with in the area, then offers of other Area will be considered.

Project affected persons and land oustees, ex-employees/ dependants of exemployees who have been allotted/already selected for deployment of vehicles at any Area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.
