Applications are invited from interested vehicle owners/contractors to deploy the subject vehicles along with Drivers for the above purpose for use at RG.I Area Mines & Departments, with the following terms & conditions.

1. Processing fee is Rs.590.00 (Rupees Five Hundred Ninety only) (Non-refundable) per vehicle offered shall be paid in the form of cash only at Cash Office, RG.1 Area and the voucher (original) shall be submitted along with the application i.e., Rs.500/- + Rs.90/- (18% GST).

3 a) In case the tenderer is a project affected/Project displaced person, his tender should accompany the following:

i) A letter duly signed by the tenderer with the following details:

- Extent of his land acquired
- Survey No.
- Village
- Mandal
- Award No. and date
- Purpose for which it was acquired

ii) A certificate from the Govt. Authorities about his identity.

The eligibility of Tenderer under the above category is subject to verification of the genuineness of the details submitted by the tenderer.

b) In case of Dependants of ex-employees of SCCL or ex-employees of SCCL, they should submit any of the following document to the respective Personnel Department of SCCL of that area.

SCCL Identity Card/Hospital Book/SCCL Pay Slip with Employee code Number

After submitting any of the above, they should get certificate that he is Dependant of ex-employee of SCCL or ex-employee of SCCL from that Area and submit the same to In-charge, Personnel Department, RG.I Area. Further, the In-charge. Personnel Department, RG.I Area will give a certificate and the same is to be enclosed to the application.

c) In case the tenderer is a driver-cum-owner, he is requested to submit the relevant documents (valid driving license etc.)

***Without the above documents, the applications received cannot be considered for preference category***

#### 4. Tender Evaluation Process:

Preference for awarding the contract will be given in the following order.

- a) Project affected persons means project displaced persons and land ouster come under 1st Category and they are to be treated equally.  
If 1<sup>st</sup> category persons are not available, then 2<sup>nd</sup> category persons will be given opportunity.
- b) Dependents of Ex-employees of SCCL who are not provided with job or ex-employees of SCCL are come under 2<sup>nd</sup> category.  
If 2<sup>nd</sup> category persons are not available, then 3<sup>rd</sup> category persons will be given opportunity
- c) Others come under 3<sup>rd</sup> category

**Note:** First preference will be given to RG.I Area persons only. If no person is received with in the area, then offers of other Area will be considered.

Project affected persons and land oustees, ex-employees/ dependants of ex-employees who have been allotted/already selected for deployment of vehicles at any Area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.

After completion of the tender process and placement of order, if it is found that the person is already allotted/selected for deployment of vehicle at any other area of SCCL, the vehicle will be withdrawn immediate and EMD/Security deposit and pending bills if any, will be forfeited.

5) Tender Application can be obtained from Cash Office, Ramagundam Area-I before 09.07.2019 up to 4.00 pm on **payment of Rs.590/- (Rupees five hundred Ninety only) towards tender processing fee** at Cash Office, Ramagundam Area-I.

6) **EMD and Security Deposit:** EMD Rs.25,000.00 if the tenderer opted for A/c Ambulance, Rs.15,000.00 if the tenderer opted for 2WD/4WD Vehicles, Rs.7,500.00 shall be submitted in the form of Demand Draft only payable at State Bank of India, SCCL Branch, Godavarikhani along with application.
