b) In case of Dependants of ex-employees of SCCL or ex-employees of SCCL, they should submit any of the following document to the respective Personnel Department of SCCL of that area.

SCCL Identity Card/Hospital Book/SCCL Pay Slip with Employee code Number

After submitting any of the above, they should get certificate that he is Dependant of ex-employee of SCCL or ex-employee of SCCL from that Area and submit the same to In-charge, Personnel Department, RG.I Area. Further, the In-charge. Personnel Department, RG.I Area will give a certificate and the same is to be enclosed to the application.

c) In case the tenderer is a driver-cum-owner, he is requested to submit the relevant documents (valid driving license etc.)

Without the above documents, the applications received can not be considered for preference category

5. Tender Evaluation Process:

<u>Evaluation criteria</u>: Vide Approved Note.No.CRP/MP/Sec19/449, Dtd.01.07.2021, the evaluation process for Unit rate vehicles for selection of successful bidder will be selected by lottery system as below.

- 1. Lottery shall be conducted in Unit rate vehicles enquiries among all the received bids by intimating the convenient date of draw to the firms who have submitted the bids for the enquiry. The date of draw shall be intimated by displaying on Notice Boards.
- 2. Draw will be conducted for number of firms equal to the number of vehicles and the firms will be selected. Additionally a number of firms equal to twice the number of vehicles will also be selected in the lottery and will be kept as standby.
- 3. All the above firms which are selected in the lottery along with standby firms selected in lottery will be given lottery serial number and sent for technical evaluation.
- **4.** On confirming the technically and commercially acceptability the firms which are standing in lottery serial will be considered for the award of contract. Firms in the standby list will be considered for award of contract as per serial number in the lottery list on confirming their technically and commercially acceptability if any dropouts before their serial number. The standby list will be maintained for a period of 2(Two) years from the date of opening of enquiry for future requirements of vehicles, if any.

- 6. Preference for awarding the contract will be given in the following order.
- a. Project effected persons means project displaced persons & land oustees and unemployed youth of surrounding villages i.e.,
 - (i) Janagoan
 - (ii) Sundilla.
 - (iii) Mustyala
 - (iv) Vittalnagar,GDK come under Ist Category and they are to be treated equally.
- b. Dependents of Ex-employees of SCCL who are not provided with job or ex- employees of SCCL are come under 2nd category.
 If 2nd category persons are not available, then 3rd category persons will be given opportunity
- c) Others come under 3rd category
- **Note:** First preference will be given to RG.I Area persons only. If no person is received with in the area, then offers of other Area will be considered.
 - 7. Project displaced persons and land oustees, ex-employees/ dependants of ex-employees who have been allotted/already selected for deployment of vehicles at any Area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.
 - 8. After completion of the tender process and placement of order, if it is found that the person is already allotted/selected for deployment of vehicle at any other area of SCCL, the vehicle will be withdrawn immediate and EMD/Security deposit and pending bills if any, will be forfeited.
 - EMD and Security Deposit: EMD Rs.5,000/- if the tenderer opted for 2WD Jeeps & 1Ton or above capacity pickup van 4Wheel Drive, shall be submitted in the form of Demand Draft only payable at State Bank of India, SCCL Branch,Godavarikhani along with application.
