Applications are invited from interested vehicle owners/contractors to deploy the subject vehicle along with Drivers for the above purpose with the following terms & conditions.

1. Processing fee (Non-Refundable): An amount of Rs.590/- (Rupees Five Hundred and Ninety only) Rs.500/- + Rs.90/- GST per tender schedule is to be paid by cash only, at the office of DGM(F&A), RG.I and on submission of receipt along with application. Tender forms can be obtained from the office of DGM(Purchase), office of the General Manager, Ramagundam Area-I.

3 a) In case the tenderer is a project affected/Project displaced person, his tender should accompany the following;

i) A letter duly signed by the tenderer with the following details:

- Extent of his land acquired
- Survey No.
- Village
- Mandal
- Award No. and date
- Purpose for which it was acquired

ii) A certificate from the concerned Govt. Authorities about his identity.

iii) AADHAAR CARD details and PAN Card (if available) details

The eligibility of Tenderer under the above category is subject to verification of the genuineness of the details submitted by the tenderer.

- b) In case of Dependants of ex-employees of SCCL or ex-employees of SCCL, they should submit any of the following document to the respective Personnel Department of SCCL of that area.

SCCL Identity Card/Hospital Book/SCCL Pay Slip with Employee code Number

After submitting any of the above, they should get certificate that he is Dependant of ex-employee of SCCL or ex-employee of SCCL from that Area and submit the same to In-charge, Personnel Department, RG.I Area. Further, the In-charge. Personnel Department, RG.I Area will give a certificate and the same is to be enclosed to the application.

- c) In case the tenderer is a driver-cum-owner, he is requested to submit the relevant documents (valid driving license etc.)

Without the above documents, the applications received can not be considered for preference category

4. Tender Evaluation Process:

Preference for awarding the contract will be given in the following order.

- a) Project affected persons means project displaced persons and land ouster come under 1st Category and they are to be treated equally.
If 1st category persons are not available, then 2nd category persons will be given opportunity.
- b) Dependents of Ex-employees of SCCL who are not provided with job or ex-employees of SCCL are come under 2nd category.
If 2nd category persons are not available, then 3rd category persons will be given opportunity
- c) Others come under 3rd category

Note: First preference will be given to RG.I Area persons only. If no person is received with in the area, then offers of other Area will be considered.

Project displaced persons and land oustees, ex-employees/ dependants of ex-employees who have been allotted/already selected for deployment of vehicles at any Area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.

After completion of the tender process and placement of order, if it is found that the person is already allotted/selected for deployment of vehicle at any other area of SCCL, the vehicle will be withdrawn immediate and EMD/Security deposit and pending bills if any, will be forfeited.
