1. Offers are invited for Contract for LP Gas door delivery from Singareni Super Bazar Indane Gas and Bharat Gas Distributorship points of RG.1 Area to the residences of SCCL employees for a period of two years under unit rate system' on the basis of workable rates fixed as detailed below;

2. The total LPG Door Delivery contract period will be in force for a period of TWO years Initially the period is for 3 months on trial basis. The extension of further period of one year and Nine months depends on the performance of the Tenderer.
3. Payment shall be made on monthly basis for the number of cylinders delivered.

The prescribed '**TENDER FORM**' together with terms and conditions can be collected from O/o Dy.SE(Purchase), RG.I, GM, RG.1 Office, Godavarikhani by remitting non-refundable "Tender Form Cost" of Rs.118.00 (Rupees One hundred + 18% GST) in the Cash Office, F&A Dept., RG.1 from **27.01.2026 to 16.02.2026 upto 4.00 P.M**
6. Tenderer shall submit bids along with EMD of –
- a) Rs.60,000/-(Rupees Sixty Thousand only) for participating in Indane LPG Cylinders Door Delivery
 - b) Rs.60,000/-(Rupees Sixty Thousand only) for participating in Bharat LPG Cylinders Door Delivery

Demand Draft shall be drawn in favour of The Singareni Collieries Company Ltd., Ramagundam Area-1, payable at State Bank of India, SCCL Branch, Godavarikhani only from **any nationalized bank** along with the Tender Form. Draw will be conducted for Technically and commercially bidders and selection will be made for 3 bidders. 2nd and 3rd bidders (Stand by) EMD will be returned after monitoring the performance of successful bidder for a period of 3 months. Return of EMD to the unsuccessful Tenderers shall be made after finalization of the Tenders. The EMD of the successful Tenderers shall be refunded after two months on completion of the order period and on satisfactory performance certification from **Divisional Manager, SCCC Stores Ltd, Godavarikhani**. No interest shall be paid on the EMD amount.

The successful Tenderer shall deploy trolley for distributorship (Indan and Bharat separately) and should deposit **Rs.1,00,000/- per each vehicle by way of Demand Draft in favour of The SCCC Stores Ltd, GDK payable at State Bank of India, SCCL Branch, Godavarikhani** obtained from **any Nationalized Bank** only towards security/caution deposit. The security/caution deposit shall be refunded after two months on completion of the Tender period. No interest shall be paid on the security/caution deposit amount.
8. Bidders may participate either in Indane LPG Cylinders Door Delivery, or in Bharat LPG Cylinders Door Delivery, RG.1 Area and also in both the above LPG Cylinders Door Deliveries along with the prescribed EMDs.

14. The draw will be conducted from the technically and commercially qualified bidders with prior intimation.
15. The selection of successful bidders shall be made on the basis of lottery system from among the technically and commercially qualified bidders. Selection will be made for 3 bidders to each distributorship i.e. Indane Gas and Bharat Gas. Second and third bidder will be on standby.
