5. **LOTTERY PROCEDURE:**

1. The Enquiry will be opened as per the scheduled Date & time and all the bids will be given Numbers, which will be the tender serial number for total processing period of the enquiry.
2. If offers are received for more than the required number of vehicles, then successful Tenderer will be selected through suitable lottery system.
3. The lottery will be conducted within two weeks after the bid submission closing and Lottery date will be displayed in notice boards of Area purchase department and GM office of RG3 Area.

5. **Total Thirty Six (36) bids** will be selected through lottery from the total bids received with necessary documents as per NIT and send for technical evaluation.
6. Out of technically & commercially acceptable bids, First Twelve (12) Nos bids as per lottery serial number will be considered for awarding contract for hiring subjected above terms and conditions. Keeping in view of the probable requirement, balance technically and commercially acceptable bids will be kept as stand by for the next two(2) year from the date of opening of present enquiry for placing orders against additional requirement / cancellation of existing orders, with same prices, terms & conditions and price variation formula.
