I) **New unit rate/month =**

- 3. Processing fee of Rs.590/-** (Rupees Five Hundred and Ninety only) (Non-Refundable) per vehicle offered shall be paid in the form of cash at cash office and the voucher shall be submitted along with application.
- 4. EMD and Security Deposit:** EMD of Rs.10,000.00 (Rupees Ten Thousand only) per vehicle shall be submitted by way of DD only payable at SBI Centenary Colony in favor of The Singareni Collieries Co. Ltd. The successful tenderer shall deposit a sum of Rs.00,000/- per vehicle as security deposit by way of DD within two weeks from the date of commencement of the work. This amount and EMD will bear no interest and will be refunded after 3 months from the date of expiry of the contract period and on satisfactory completion of the work.

**Project affected persons, Ex-employees of SCCL and Dependents of Ex-Employees are exempted for payment of EMD. Others shall pay an amount of Rs.10000.00 per vehicle towards EMD**

**6. Eligibility Criteria:**

Preference for awarding the contract will be given in the following order.

- a) **1<sup>st</sup> Category:** Project affected persons means project displaced persons and Land oustees come under 1<sup>st</sup> category and they will be treated equally.

**Note:** If 1<sup>st</sup> category persons are not available then 2<sup>nd</sup> category persons will be given opportunity.

- b) **2<sup>nd</sup> Category:** Dependents of Ex-employees of SCCL who are not provided job or Ex-employees of SCCL come under 2<sup>nd</sup> category.

**Note:** If 2<sup>nd</sup> category persons are not available then 3<sup>rd</sup> category persons will be given opportunity.

**c) 3<sup>rd</sup> Category:** others come under 3<sup>rd</sup> category

Persons falling under category 1&2 are permitted to deploy one vehicle per head only. Further, it is to inform that first preference will be given to RG3 & APA area only. If no response is received within the Area, then the offers of the other Areas will be considered in the same order of eligibility criteria.

Project displaced persons and land oustees, ex-employees/dependents of ex-employees who have been allotted/already selected for deployment of vehicle at any Area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.

After completion of the tender process and placement of order, if it is found that the person is already allotted/selected for deployment of vehicle at any other Area of SCCL, the vehicle will be withdrawn immediately and EMD and Security Deposit and pending bills, if any, will be Forfeited.

**7.** If the tenderer is Project affected person/Project displaced persons, his tender should accompany the following:

1. A letter duly signed by the tenderer with the following details:

- a. Extend of land acquired
- b. Survey no.
- c. Village,
- d. Mandal
- e. Award no. & date
- f. Purpose for which it was acquired

2. Certificate from the concerned Government authorities about his identity.

Eligibility of the tenderer under the above category is subject to verification of the genuineness of the details submitted by the tenderer.

**8.** In case of Dependents of Ex-employees of SCCL who are not provided job or Ex-employees of SCCL, they should submit any of the following documents to the respective personnel department of SCCL of that Area.

SCCL Identity card/Hospital Book/SCCL pay slip with Employee code no. after submitting any of the above, they should get certificate that he is dependent of Ex-employee of SCCL or Ex-employee of SCCL from that Area and submit the same to In charge, Personnel Dept, the In charge, Personnel Department will forward the same to be enclosed to the application after due certification.

Without the above documents, the applications received cannot be considered for preference category.

**9.** One application will be considered for each land looser. In case of multiple applications received against single award, only one application shall be considered through lottery system among the applications received against the award.

**10.** Only one application shall be considered even the land acquired through different awards.

11. If the original awardee is not alive, only one legal heir is eligible of filling of applications as Project Affected Families/ Project displaced families, subject to submission of necessary proof of documentary evidence.
12. If technically acceptable offers are received for more than the required number of vehicles, then successful tenderer will be selected through suitable Lottery system.
13. Tender forms can be obtained from DGM (Purchase), Purchase Dept., APA.
