1. Sealed tenders are invited from prospective tenderers for Hiring of AC/ 2WD Hard Top Jeep(Bolero) 24 Hrs availability for use at Goleti CHP, under unit rate system initially for a period of 3 years, (later on further 2 more years as per requirement depending on condition of the vehicle and other parameters) Bellampalli Area of SCCL situated in Kumuram Bheem Asifabad District of Telangana state.

2WD Hard top Bolero Jeep (A/c- 24 HRS AVAILABILITY):

- Model of the vehicle : **Vehicle which should be registered on or after TENDER OPENING DATE**
- Type of vehicle : 2 Wheel Drive Hard top A/c (BOLERO or equivalent Jeep
- a. CC of the vehicle : 2400cc and above
 - b. Diesel Driven : 2 Wheel Drive.
 - c. Closed type hard top / FRP
 - d. Bolero (Hard Top) / Tata Sumo (Hard Top)/Equivalent vehicle
Complying the above specifications
 - e. **The vehicle should be in the name of the successful Contractor only.**

The SCCL reserves the right to reject any or all the tenders without assigning any reason.

II. Tender Evaluation Process:

Preference for awarding the contract will be given in the following order.

- i. Project affected persons / Project displaced persons come under 1st category.
- ii. Dependents of Ex employees of SCCL or Ex-employees of SCCL come under 2nd category.
- iii. Others come under 3rd category.
- iv. Priority will be given to 1st category persons, if not available, 2nd category persons and like wise.
- v. Persons fall under category 1 & 2 are permitted to deploy only one vehicle at any given point of time at any place in SCCL.

If the tenderer is Project affected person, Ex- employee of SCCL or dependant of ex-employees, proof to that effect shall be enclosed duly signed by head of Estates Department / Personal department of concerned area.

If technically acceptable offers are received for more than the required number of vehicles, then successful Tenderers will be selected through suitable **lottery system**.

3. The 2WD Hard top jeep with A/c on 24 Hrs availability at Goleti CHP, BPA Area shall be hired under **Unit Rate System** as shown in NIT

4. **Eligibility:** Successful Tenderer shall be decided through draw of lottery among the applicants who wish to carryout the work as per the priorities given below:

Preference for awarding the contract will be given in the following order.

- vi. Project affected persons / Project displaced persons come under 1st category.
- vii. Dependents of Ex employees of SCCL or Ex-employees of SCCL come under 2nd category.
- viii. Others come under 3rd category.
- ix. Priority will be given to 1st category persons, if not available, 2nd category persons and like wise.
- x. Persons fall under category 1 & 2 are permitted to deploy only one vehicle at any given point of time at any place in SCCL.

If the tenderer is Project affected person, Ex- employee of SCCL or dependant of ex-employees, proof to that effect shall be enclosed duly signed by head of Estates Department / Personal department of concerned area.

NOTE: Offers received from prospective Tenderers of Bellampalli Area who fall under 1st & 2nd Category will be given first preference for choosing Successful Tenderer. If no response is received from BPA Area, the offers of other Areas of SCCL will be taken into consideration.

If technically acceptable offers are received for more than the required number of vehicles, then successful Tenderers will be selected through suitable lottery system.

5. **Processing Fee of Rs.590/-** (Rupees Five Hundred and Ninety only shall be paid in the form of cash at Cash Office and the voucher shall be submitted along with application.

EMD for Rs.7,500/- per Vehicle shall be submitted along with Tender by 3rd Category Tenderers only. 1st & 2nd Category Tenderers are **exempted** from submission of EMD. The successful Tenderer shall deposit a sum of **Rs.10,000/- per Vehicle** as further **Security Deposit** within 2 weeks from the date of commencement of work. The amounts can be either by Cash or by DD.
