### ii. Specifications for 1 No.A/C Ambulance:

Model of the vehicle: first time registered vehicle as on the date of opening of the enquiry

- Two fans to be provided in the patient cabin.
- Multiple handle bars to be fixed.

- Provision for Mobile charger to be fixed.

- The statutory items/fixtures for ambulance should be fixed ie emergency lights, back lights, warning lights, front light bar and siren etc.,
