Sealed tenders are invited from prospective tenderers for Hiring of 2 Nos. of 3T Platform Truck (24 hrs availability per day) under Unit Rate System, for a period of 3 years (later on further 1 more year as per requirement depending on condition of the vehicle and other parameters) Khairagura OCP & Area Workshop, BPA Area of SCCL situated in Kumuram Bheem Asifabad District of Telangana State.

**Specifications for 3T Platform Truck:**

- a. Model of the vehicle: **LATEST ON OR AFTER TENDER OPENING DATE.**
- b. Type of vehicle : 3T capacity Platform Truck
- c. Wheel Drive : 2 Wheel Drive.
- d. Seating capacity : 1+2 Seats in the Driver cabin

**TERMS AND CONDITIONS:**

1. The Contract shall be valid for a period of 3 Years. The condition of vehicle / deployment status / performance will be monitored periodically and the Contract is liable for termination if the performance of Contractor is unsatisfactory at any stage. The vehicle is registered on or after the tender opening date. **The Vehicle shall be registered in the Name of the Firm only.** Vehicles with permanent registration & valid fitness issued by Transport Authorities are only permitted for deployment and vehicles with temporary registration will not be accepted. The Vehicle documents must be available with the driver at all times.
2. The Contractor should follow all the labour legislations as amended from time to time including the minimum wages Act etc.

3. The Contractor should produce their bank account number with proof. Payment to the drivers shall not be less than minimum wages as per **act** and the contractor shall pay wages to the driver(s) through bank only.
4. The duration of the availability is for 24 hours a day.
5. The Vehicles are required to be provided on all working days of the Mine including weekly play days and holidays. For Vehicles hired on 24 hours basis, eight hours / week will be spared on weekly holiday for maintenance works. Three Driver for 24 Hours Vehicle are to be deployed.
6. The rate per extra KMs run beyond Scheduled KMs run per month, additional charges per hour for utilization of vehicle beyond scheduled hours on any day and daily allowance for driver out station trips will be paid as under:

### **7. Taxes etc.:**

a). Notwithstanding anything contained in the NIT document, Taxes and other statutory levies if any applicable during the execution period of the contract, will be to contractor / agency account. The successful tenderer, other than Project affected persons / dependents of ex-employees of SCCL or ex-employees of SCCL should furnish the proof of turnover of previous year.

b). Introduction of new taxes / duties or with-drawl of taxes / duties if any shall be to the account / credit of SCCL as the case may be.

### **Note:**

The vehicle engaged on hire basis come under the category of "Rent-a-Cab scheme operator's Service" under the GOODS and Service Tax provisions. GST will be paid by SCCL under RCM to Government, if the bidder is unregistered under GST

***NOTE:- As per previous approved notes enquiry being floated for 3 T Plat form Trucks, by the time of deployment any up gradation in specifications and prices shall be considered for BS-6 vehicles as per directives from corporate.***

### **Eligibility criteria:**

Preference for awarding the contract will be given in the following order.

- i. Project affected persons / Project displaced persons come under 1st category.
- ii. Dependents of Ex employees of SCCL or Ex-employees of SCCL come under 2nd category.
- iii. Others come under 3<sup>rd</sup> category.

- iv. Priority will be given to 1<sup>st</sup> category persons, if not available, 2<sup>nd</sup> category persons and likewise.
- v. Persons fall under category 1 & 2 are permitted to deploy only one vehicle at any given point of time at any place in SCCL.

If the tenderer is Project affected person, Ex- employee of SCCL or dependant of ex-employees, proof to that effect shall be enclosed duly signed by head of Estates Department / Personal department of concerned area.

If technically acceptable offers are received for more than the required number of vehicles, then successful Tenderers will be selected through suitable **lottery system**.

**Note:** Further, it is to mention that First Preference will be given to BPA Area persons only, if no response is received within the Area, then offers of other Area will be considered in the same order of eligibility criteria.

**The SCCL reserves the right to reject any or all the tenders without assigning any reason.**

**4. Processing Fee of Rs.590/-** (Rupees Five Hundred and Ninety only) shall be paid in the form of cash at Cash Office and the voucher shall be submitted along with application.

**5. Tender Evaluation process::**

Successful Tenderer shall be decided through draw of lots among the applicants who wish to carry out the work as per the priorities given at eligibility criteria:

NOTE: Offers received from prospective Tenderers of Bellampalli Area who fall under 1<sup>st</sup> & 2<sup>nd</sup> Category will be given first preference for choosing Successful Tenderer. If no response is received from BPA Area, the offers of other Areas of SCCL will be taken into consideration.

**The SCCL reserves the right to reject any or all the tenders without assigning any reason.**

**6. EMD for Rs. 7,500/- Per Vehicle** shall be submitted along with Tender by 3<sup>rd</sup> Category Tenderers only. 1<sup>st</sup> & 2<sup>nd</sup> Category Tenderers are exempted from submission of EMD. The successful Tenderer shall deposit a sum of **Rs.5,000/- per Vehicle** as further **Security Deposit** within 2 weeks from the date of commencement of work along with Rs.100/- Non Judicial bond. The amounts can be either by Cash or by DD.
