THE SINGARENI COLLIERIES COMPANY LIMITED, Mandamarri Area desires for 4WD Jeep Non A.C.-2 Nos., 2WD Jeep MUV Non A.C.- 2 Nos.(2wd Jeep-1 and MUV-1)., 4WD Non A.C. Camper - 1 Nos. 2WD Non A.C. Camper - 2 Nos. (12Hrs -1and 24Hrs-1) and A.C. Ambulance -3 Nos. on hire basis UNDER UNIT RATE SYSTEM for use at RK OCP,Forest Dept, Survey Dept,AWS(Solar Power Plant)AH.RKP-2Nos and Kasipet -1No., MM Area with the following terms & conditions.

1. Applications are invited from interested vehicle owners/contractors to deploy the subject vehicles along with Driver on hire basis for use various depts., and Mines of MANDAMARRI AREA, THE SINGARENI COLLIERIES COMPANY LIMITED situated in Mancherial District.
2. **PROCESSING FEE (NON REFUNDABLE):** An amount of Rs.590/-(Rupees Five Hundred and Ninety only] Rs.500/-+ Rs.90/-GST per tender schedule is to be paid by cash only, at the office of AGM (F&A) / MM and on submission of receipt along with application, Tender forms can be obtained from the office of DGM (E&M)Purchase/MM, office of General Manager, Mandamarri, P.O. Kalyanikhani, Mancherial District, PIN 504 231.
3. EMD: Rs.10,000/- (Rupees Ten thousand only) towards Earnest Money Deposit to be paid per each vehicle by Demand Draft from State Bank of Hyderabad,/Andhra Bank, in favour of The Singareni Collieries Company Ltd payable at Mandamarri only. DD payable on out station banks will not be accepted. DDS WITH THREE MONTHS VALIDITY ONLY WILL BE ACCEPTED. TENDER WITHOUT EMD WILL NOT BE CONSIDERED AND THEIR OFFERS STAND DISQUALIFIED. No interest will be paid by SCCL on EMD amount. The successful tenderer shall deposit a sum of Rs. 5,000/- (Rupees Five Thousand only) per each vehicle as further security deposit (either by cash or by DD) within two weeks from the date of commencement of work.

E.M.D. of unsuccessful tenderers will be refunded only after finalization of tenders.

b. **REQUIREMENTS (compulsory):**

- Two fans to be provided in the patient cabin.
- Multiple handle bars to be fixed.
- Multiple CFL Light points to be provided.
- Wall clock to be fixed in the cabin.
- Provision for Mobile charger to be fixed.
- Two way communication with cabin/driver.
- O2 (Oxygen) cylinder to fix with sufficient clamps to avoid movement and sound during running.

- Extra shock absorbers for smooth riding comfort to the patient.
- Space for all medical equipment i.e. Ventilator, Multipara Monitor, Defibrillator, Infusion pump, Suction apparatus and Monitors etc.,
- Aluminium / Hindalium pull out stretchers.
- Extra battery / large capacity to run the equipment.
- Room thermometer to be fixed in the cabin.
- Fire extinguisher to be provided.
- Provision for fixing sphygmomanometer 15cm dial type.
- Provision for Emergency medical jump kit or drug kit.
- Modern and plush interiors with neat and excellent finish.
- The statutory items/fixtures for ambulance should be fixed i.e., emergency lights, back lights, warning lights, front light bar and siren etc.,
- To keep sufficient fuel in the tank of the Ambulance to complete the trip
- One foldable wheel chair in the Ambulance
- Provision of GPS system to monitor through our VTS System shall be made available in the Ambulance by the firm
- Copy of the Driving License of the concerned Driver should be displayed in the Ambulance.
- The driver should wear ID card issued by concerned authorities and also the driver should wear Shoes and Uniform.

**NOTE:** The Area GM/GM(E&M)Transport has right to refuse the person responsible for contravention if any to enter in to the premises of the Company's establishments till the cause of such contravention is removed or informed in writing of the corrective action taken by contractor with an assurance about non-recurrence of such contravention

5. Eligibility criteria for preference category/ Tender Evaluation process:  
Preference for awarding the contract will be given in the following order:

- a. 1<sup>st</sup> Category: Project affected persons means project displaced persons and land oustees come under 1<sup>st</sup> category and they are to be treated equally.

NOTE: If the requirement of vehicles is not met with the above category then 2<sup>nd</sup> category persons will be given opportunity.

- b. 2<sup>nd</sup> Category: Dependants of Ex-employees of SCCL who were not provided with job (or) Ex-employees of SCCL come under 2<sup>nd</sup> category.

**NOTE:** If the requirement of vehicles is not met with the above Category then 3<sup>rd</sup> category persons will be given opportunity.

- c. 3<sup>rd</sup> category: Others come under 3<sup>rd</sup> category. If requirement is not met with category I & II above, then 3<sup>rd</sup> category persons will be given opportunity.

NOTE: If no response is received within the area, then offers of other areas will be considered in the same order of eligibility criteria.

- d. In case the tenderer is a land oustee/ PDF while submitting tender he should furnish the following information along with documental evidence without which the offer will not be considered for the subject tender.
- i. Extent of land acquired.
  - ii. Survey No.
  - iii. Village
  - iv. Mandal
  - v. Award No. & Date
  - vi. The purpose for which the land was acquired.
  - vii. Certificate from the concerned Govt. authorities about his identity with photograph.

**On verification of above documents and certification from Area Estates Officer only, the offer will be considered for subject tender.**

- e. In case of dependants of ex-employees of SCCL who were not provided job (OR) ex-employees of SCCL they should submit any of the following documents to respective Personnel Dept. of SCCL of that Area.

**SCCL identity Card/Hospital Book/ SCCL Pay slip with employee code number.**

After submitting any of the above, they should get certificate that he is dependant of ex-employee of SCCL or ex-employee of SCCL from that area and submit the same to In-charge, Personnel Department, Mandamarri Area. Further, the in-charge, Personnel department, Mandamarri Area will forward the same to be enclosed to the application after due certification.

- f. In case the tenderer is driver-cum-owner, he is requested to submit the relevant documents like valid driving license etc.

**WITHOUT THE ABOVE DOCUMENTS, THE APPLICATIONS RECEIVED CAN NOT BE CONSIDERED FOR PREFERENCE CATEGORY.**

- g. Project affected persons/ dependants of ex-employees of SCCL (OR) ex-employees of SCCL are **permitted to deploy only one vehicle per head.**

**NOTE: Project affected persons/dependants of ex-employees/ex-employees of SCCL who have been allotted/already selected for deployment of vehicles at any other Area of SCCL under Unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.**

**After completion of tender process and placement of order, if it is found that the person is already allotted / selected for deployment of vehicle at any other area of SCCL under Unit Rate System, the vehicle will be withdrawn immediately and EMD & security deposit will be forfeited.**

- h. Project affected Persons/ dependents of Ex-employees of SCCL (OR) ex-employees of SCCL are **permitted to deploy only one vehicle per head**.
6. In case, the number of eligible offers received are more than the required number of vehicles, the successful tenderer will be decided through draw of lots in the same order of eligibility criteria for preference category as mentioned at point no.6.

8. Closing date of tenders : 26.03.2019 at 12.00 Noon.
9. Opening date of Tenders : 26.03.2019 after 3.00 P.M.

**NOTE:**

- i. Tenders submitted without the following will not be considered.
- a) Requisite EMD.
- b) Under preference category, if tenders submitted without RELEVANT CERTIFICATE from the concerned authorities as mentioned above.
- ii. The date and time of draw will be displayed on the notice board of Purchase Dept., MM after scrutiny of the tenders. Successful tenderer shall be decided through draw of lots.
- iii. Tenders should be posted in a sealed envelop clearly super-scribed with Enquiry Number, date, name of the person, Father's name, address, phone numbers who is submitting the tender. Without the above & unsigned quotations will not be considered.
- iv. The successful tenderers under preference category should produce certificates IN ORIGINAL WITH PHOTO IDENTITY BEFORE RELEASE OF ORDERS.
