- 2. **PROCESSING FEE** (NON REFUNDABLE): An amount of Rs.590/-(Rupees Five Hundred and Ninety only] Rs.500/-+ Rs.90/-GST per tender schedule is to be paid by cash only, at the office of DGM (F&A)/ MM. On submission of receipt along with application, Tender forms can be obtained on any working day between 10.00AM to 4.30PM from Dy.S.E(E&M)Purchase/MM, office of General Manager, Mandamarri, P.O. 3. EARNES MONEY DEPOSIT:

- a) For 2WD A.C.Jeeps, Non.A.C.Jeeps 4WD Non.A.C.Camper/1.0Ton capacity Pickup Van Rs.7,500/- (Rupees Five Thousand and Seven Hundred Only).

4. **SECURITY DEPOSIT**: The successful tenderer shall deposit a sum of Rs. 5,000/- (Rupees Five Thousand only) per each vehicle and Rs.10,000/- (Rupees Ten thousand only) for Non Ambulance as further security deposit (either by cash or by DD) within two weeks from the date of commencement of work and refunded after completion of contract.

b. **REQUIREMENTS** (compulsory):

- The Non Ambulance should be of standard design and should have minimum two stretcher holders cum flats seats both sides with suitable thickness and flat foam cushion seats to avoid discomfort to the patient, one scoop stretcher, two attendants seats in patients cabin, one Doctors seat in Drivers Cabin, stand for 2 saline bottles, Hangers for l.V. Fluids preferably with bottle, First Aid Box, Drug Cabinet, Water Tank and Wash Basin etc.
- Monococque Type Body (108Type Model).
- Provision of sliding windows should be provided in case of A/C System failure (for Non AC Ambulance).
- A/C vent should be Roof mounted (for AC Ambulance).
- Vinyl flooring which should be easily washable and for the purpose of disinfecting the Ambulance after shifting of the patient.

- Seat Belts/ Restraints both for patients and the attendant seat should be provided. One foldable Wheel Chair should be provided in the Ambulance.
- Stretcher-1No.
- Two fans to be provided in the cabin.
- Multiple handle bars to be fixed.
- Multiple CFL Light points to be provided.
- Wall clock to be fixed in the cabin.
- Provision for Mobile charger to be fixed.
- Two way communication with cabin/driver.
- O2Cylinder to fix with sufficient clamps to avoid movement and sound during running.
- Space for all medical equipment i.e. Ventilator, Multipara Monitor, Defibrillator, infusion pump, Suction apparatus and Monitors etc.,
- Aluminum / Hindalium pull out stretchers.
- Extra battery/ large capacity to run the equipment.
- Room thermometer to be fixed in the cabin.
- Fire extinguisher to be provided.
- Provision for fixings phygmomanometer15cm dials type.
- Provision for Emergency medical kit or drug kit.
- Modern and plush interiors with neat and excellent finish.
- The statutory items/ fixtures for vehicle should be fixed i.e. emergency lights, backlights, warning lights, front light bar and siren etc.,
- Suction apparatus is to be provided and fixed in the patient cabin.
- Intubation Kit is also to be provided for air way management
- Sufficient AC i.e., of 1.5Toncapacity A/C is to be fitted in AC Ambulances.
- To keep sufficient fuel in the tank of the Ambulance to complete the trip
- Provision of GPS system to monitor through our VTS System to know the movement & proper usage of Ambulance
- To display the Driving License of the concerned driver in the Ambulance, driver should wear ID card issued by concerned authorities and also the driver shall wear Shoes and Uniform
- The Area GM/GM(E&M)Transport has right to refuse the person responsible for contravention if any to enter in to the premises of the Company's establishments till the cause of such contravention is removed or informed in writing of the corrective action taken by contractor with an assurance about non-recurrence of such contravention.

- 5. <u>Eligibility criteria for preference category/ Tender Evaluation process:</u> Preference for awarding the contract will be given in the following order:
 - a. 1st Category: Project affected persons(PAPs)/Project Displaced Persons(PDPs) and land oustees come under 1st category and they are to be treated equally.
 - **NOTE:** If the requirement of vehicles is not met with the above category then 2nd category persons will be given opportunity.
 - b. **2**nd **Category**: Dependants of Ex-employees of SCCL who were not provided with job (or) Ex-employees of SCCL come under **2**nd category.
 - **NOTE:** If the requirement of vehicles is not met with the above Category then 3rd category persons will be given opportunity.
 - c. **3**rd **category**: Others come under 3rd category. If requirement is not met with category I & II above, then 3rd category persons will be given opportunity.
 - **NOTE:** If no response is received within the area, then offers of other areas will be considered in the same order of eligibility criteria.
 - d. In case the tenderer is a land oustee/ PDF while submitting tender he should furnish the following information along with documental evidence without which the offer will not be considered for the subject tender.
 - i. Extent of land acquired.
 - ii. Survey No.
 - iii. Village
 - iv. Mandal
 - v. Award No. & Date
 - vi. The purpose for which the land was acquired.
 - vii. Certificate from the concerned Govt. authorities about his identity with photograph.

On verification of above documents and certification from Area Estates Officer only, the offer will be considered for subject tender.

- e. If already vehicle deployed on the name of awardees or their legal heirs of Ex-employees/dependents of Ex-employees/Land looser/Project affected persons(PAF) / Project displaced person(PDF) under unit rate system any area of SCCL may not considered again during the same period against land/house under total awards even though land or houses acquired in different awards.
- f. If the tenderer finds as defaulter in earlier deployed Vehicle against any order in the SCCL his offer will not be considered.

g.In case of dependants of ex-employees of SCCL who were not provided job (OR) ex-employees of SCCL they should submit any of the following documents to respective Personnel Dept. of SCCL of that Area.

SCCL identity Card/Hospital Book/ SCCL Pay slip with employee code number.

After submitting any of the above, they should get certificate that he is dependant of ex-employee of SCCL or ex-employee of SCCL from that area and submit the same to In-charge, Personnel Department, Mandamarri Area. Further, the in-charge, Personnel department, Mandamarri Area will forward the same to be enclosed to the application after due certification.

h. In case the tenderer is driver-cum-owner, he is requested to submit the relevant documents like valid driving license etc.

WITHOUT THE ABOVE DOCUMENTS, THE APPLICATIONS RECEIVED CAN NOT BE CONSIDERED FOR PREFERENCE CATEGORY.

 Project affected persons/ dependants of ex-employees of SCCL (OR) ex-employees of SCCL are permitted to deploy only one vehicle per head.

NOTE: Project affected persons/dependents of ex-employees/exemployees of SCCL who have been allotted/already selected for deployment of vehicles at any other. Area of SCCL under Unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.

After completion of tender process and placement of order, if it is found that the person is already allotted / selected for deployment of vehicle at any other area of SCCL under Unit Rate System, the vehicle will be withdrawn immediately and EMD & security deposit will be forfeited.

- 6. In case, the number of eligible offers received are more than the required number of vehicles, the successful tenderer will be decided through draw of lots in the same order of eligibility criteria for preference category as mentioned at point no.5. The date of draw shall be intimated by displaying on Notice Boards.

- i. Tenders submitted without the following will not be considered.
 - a) Requisite EMD.
 - b) Under preference category, if tenders submitted without RELEVANT CERTIFICATE from the concerned authorities as mentioned above.
- ii. Draw will be conducted for number of firms equal to the number of vehicles and the firms will be selected. Additionally a number of firms equal to twice the number of vehicles will also be selected in the lottery and will be kept as standby.
- iii. All the above firms which are selected in the lottery along with standby firms selected in lottery will be given lottery serial number and sent for technical evaluation.
- iv. On confirming the technically and commercially acceptability the firms which are standing in lottery serial will be considered for the award of contract. Firms in the standby list will be considered for award of contract as per serial number in the lottery list on confirming their technically and commercially acceptability if any dropouts before their serial number. The standby list will be maintained for a period of 2 (TWO) years from the date of opening of concerned enquiry for future requirements of vehicles, if any.
- v. Tenders should be posted in a sealed envelope clearly super-scribed with Enquiry Number, date, name of the person, Father's name, address, phone numbers who is submitting the tender. Without the above & unsigned quotations will not be considered.
- vi. The successful tenderers under preference category should produce certificates IN ORIGINAL WITH PHOTO IDENTITY BEFORE RELEASE OF ORDERS.
- vii. Sometimes issue of corrigendum may be necessary to clarify doubts raised by the bidders or to carryout corrections if any. All such corrigendum shall be displayed in company's web site www.scclmines.com/Tenders/AreaPurchase tenders only. The tenderers are therefore advised to visit the said website from time to time to keep them up dated.
