# Notice Inviting Tender

- Sub: Deployment of one number of 1.2T PF Truck with 24 hours availability, Two Numbers of Ambulance (Ac) with 24 hours availability and one number of 2WD Jeep (Non A/C) with 12 hours availability per day on hire basis under Unit rate system– Reg.

**1**. Applications are invited from the interested vehicle owners for Deployment of 1.2T PF Truck, Ambulance and 2WD Jeep (Non Ac) on hire basis under unit rate system mentioned below

- I) One number of 1.2T PF Truck with 24 hours per day, Monthly run up-to 1000 KMs and 30 days per month availability for S& PC Dept., SRP area for a period of 3 years. And may be extended for 1 more year based on condition and performance of the vehicle if it is required for SCCL.
- II) Two numbers of Ambulance (A/c) with 24 hours per day, Monthly run up-to 1000 KMs and 30 days per month availability for RK-8 Dispensary & Naspur Dispensary of SRP area for a period of 3 years. And may be extended for 1 more year based on condition and performance of the vehicle if it is required for SCCL.
- III) One number of 2WD Jeep (Non A/c) with 12 hours per day, Monthly run upto 1000 KMs and 30 days per month availability for Area safety officer, SRP area for a period of 3 years, and may be extend for 1 more year based on condition and performance of the vehicle if it is required for SCCL.

- O2 cylinder to fix with sufficient clamps to avoid movement and sound during running.
- Extra shock absorbers for smooth riding comfort to the patient.
- Space for all medical equipment i.e. Ventilator, Multipara Monitor, Defibrillator, Infusion pump, Suction apparatus and Monitors etc.,
- Aluminum / Indalium pull out stretchers.
- Extra battery / large capacity to run the equipment.
- Room thermometer to be fixed in the cabin.
- Fire extinguisher to be provided.
- Provision for fixing sphygmomanometer 15cm dials type.
- Provision for Emergency medical jump kit or drug kit.
- Modern and plush interiors with neat and excellent finish.
- The statutory items / fixtures for ambulance should be fixed i.e., emergency lights, back lights, warning lights, front light bar and siren etc.,

The Contract shall be valid initially for a period of 3 years which may be further extended if SCCL desires so, up to 1 years at the same price terms and conditions of the initial order, based on condition of the vehicle / deployment status and performance,. The tenderer should quote for latest model, first time registered vehicle after the date of opening of the enquiry. Vehicles with permanent registration & valid fitness issued by Transport Authorities are only permitted for deployment and vehicles with temporary registration will not be accepted. The Vehicle documents must be available with the driver at all times.
- b. The brand new vehicle shall be deployed within **60 days** along with driver(s) from the date of receipt of LOI or order.

To take care of revision on HSD price and Minimum wage rate, the successful tenderer will be allowed revision on pro-rata basis upward / downward at the following formula:

### For 1.2T PF Truck, Ambulance (Ac) & 2WD jeep (Non Ac):

I) New unit rate/month =

Old Rate per month + [{(M x (Variation in HSD Rate) x KMs Run)} + {30 x MF x 1.15 x (Variation in minimum wage per day)}]

II) -New Rate for Extra Hour:

Old Rate for extra hour + [{1.15 x Variation in minimum wages per day}/8]

III) New Rate for Extra KM:

(Old rate per extra km) + [M x (Variation in rate of HSD)]

MF is 3.0\_for 24 hrs availability, 2 for 16 hrs availability and 1.5 for 12 hours availability.

Out station DA for driver shall be firm throughout the contract period.

The claims, if any, for the above price variation can be made once in three months. However, applicable prices will be paid in the subsequent period.

<u>5. Processing fee is Rs. 590.00</u> (Rupees five hundred ninety only) per Schedule shall be paid in the form of Cash only at Cash Office, Srirampur Area and the voucher shall be submitted along with application i.e., Rs.500/- + Rs.90/- (18% GST).

### 6. EMD for 1.2T PF Truck, Ambulance & 2WD Jeep:

- a. For 1.2T PF Truck EMD Rs. 10,000/-(Rupees Ten thousand only) per vehicle shall be submitted along with Tender and the successful tenderer shall deposit a sum of <u>Rs. 5,000/-</u> (Rupees Five thousand only) towards <u>Security Deposit</u> (either by cash or by DD) with in two weeks from the date of commencement of work.
- b. For Ambulance EMD Rs. 22,500/-(Rupees Twenty two thousand five hundred only) shall be submitted along with Tender and the successful tenderer shall deposit a sum of <u>Rs. 10,000/-</u> (Rupees Ten thousand only) towards <u>Security Deposit</u> (either by cash or by DD) with in two weeks from the date of commencement of work.

c. For 2 WD Jeep EMD Rs. 7,500/-(Rupees Seven thousand five hundred only) shall be submitted along with Tender and the successful tenderer shall deposit a sum of <u>Rs. 5,000/-</u> (Rupees Five thousand only) towards <u>Security Deposit</u> (either by cash or by DD) with in two weeks from the date of commencement of work.

# Note: Project affected persons and Ex-employees of SCCL or their dependents are exempted to pay EMD.

Successful Tenderer shall be decided through draw of lottery among the applicants who wish to carryout the work as per the priorities given below.

- 7. <u>Eligibility</u>: Preference for awarding the contract will be given in the following order.
  - Project affected persons / Project displaced persons come under 1st category.
  - Dependents of Ex-employees of SCCL or Ex-employees of SCCL come under 2nd category.
  - > Others come under 3<sup>rd</sup> category.
  - Priority will be given to 1<sup>st</sup> category persons, if not available, 2<sup>nd</sup> category persons and likewise.
  - Persons fall under category 1 & 2 are permitted to deploy only one vehicle at any given point of time at any place in SCCL.
  - If the requirement of vehicles is not met with the above 1 & 2 categories then others will be given opportunity.
  - In case of Project affected persons/Ex-employees or Dependents of ex-employees of SCCL the vehicle should be in the name of tenderer only.

If the tenderer is Project affected person / Project displaced person, his tender should accompany the following:

1. A letter duly signed by the tenderer with the following details:

- a. Extent of land acquired
- b. Survey no.
- c. Village
- d. Mandal
- e. Award no. & date &
- f. Purpose for which it was acquired.
- 2. Certificate from the concerned Government authorities about his identity. Eligibility of the tenderer under the above category is subject to verification of the genuineness of the details submitted by the tenderer.

If the tenderer is Ex- employee of SCCL or dependant of ex-employees, proof to that effect shall be enclosed duly signed by HOD/Personal department of concerned area.

If technically acceptable offers are received for more than the required number of vehicles, then successful Tenderers will be selected through suitable lottery system.

The SCCL reserves the right to reject any or all the tenders without assigning any reason.

<u>Note:</u> Project affected persons means project displaced persons and land ouster/ ex-Employees/dependants of ex-employees who have been allotted / already selected for deployment of vehicles at any area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.

After completion of the tender process and placement of order, if it is found that the person is already allotted / selected for deployment of vehicle at any other area of SCCL the vehicle will be withdrawn immediately.

8. The SCCL reserves the right to reject any or all the tenders without assigning any reason.

- i. The tenderers are advised in their own interest to get themselves registered with the concerned statutory authorities for executing the contract with SCCL if awarded including Service Tax Registration. Any consequences arising out of non-compliance of the above, will not absolve the firm / agency from its obligations / responsibilities under the contract.
- ii. The tenderer should furnish copy of PAN No. Card and registration of the organization in their offer and clearly furnish its status whether individual / Partnership firm / Company.

The application for participating in tender is to be submitted duly signed to General Manager, SRP Area, The S.C.Co., Ltd., SRIRAMPUR before closing date.
