Applications are invited from the interested vehicle owners for Deployment of 2 WD Camper Jeep on hire basis under unit rate system for a period of 3 years with 1000KMs run per month as mentioned below

1. One number with **12 hours per day** and 30 days per month availability for Area workshop SRP Area.

## 2 WD Camper Jeep

- a. Model of the vehicle : Latest
- b. Type of vehicle : Hard Top Jeep
- c. CC of the vehicle : 2400 and above
- d. Diesel Driven : 2 Wheel Drive.
- e. Closed type hard top / FRP body. ( example Bolero also accepted)

To take care of revision on HSD price and Minimum wage rate, the successful tenderer will be allowed revision on pro-rata basis upward / downward at the following formula:

#### For 2 WD Camper Jeep:

I) New unit rate/month =

Old Rate per month + [{(M x (Variation in HSD Rate) x KMs Run)} + {30 x MF x 1.15 x (Variation in minimum wage per day)}]

II) -New Rate for Extra Hour:

Old Rate for extra hour + [ $\{1.15 \times Variation in minimum wages per day\}/8$ ]

III) New Rate for Extra KM:

(Old rate per extra km) + [M x (Variation in rate of HSD)]

Where,

New minimum wage rate per day for semi-skilled worker, as per circular of GM (Personnel) to be issued from time to time.

\* Unit rate is calculated on base rate of Diesel @ Rs. 70.72 per liter as on 15.12.2018 at Mancherial and minimum wages of semi-skilled is Rs. 437.00 per day w.e.f. 01.10.2018 as per the GM (Per), IR, PM & RC Lr.No.CRP/PER/IR/M/361/1552 dtd. 19.10.2018

#### Value for M = 0.08,

#### MF is 1.5 for 12 hours availability.

## Out station DA for driver shall be firm throughout the contract period.

The claims, if any, for the above price variation can be made once in three months. However, applicable prices will be paid in the subsequent period. **Processing fee is Rs. 590.00** (Rupees five hundred ninety only) per vehicle shall be paid in the form of Cash only at Cash Office, Srirampur Area and the voucher shall be submitted along with the application i.e., Rs.500/- + Rs.90/- (18% GST).

### EMD for for 2 WD Camper Jeep

**EMD Rs. 7,500**/-(Rupees Seven thousand five hundred only) shall be submitted along with Tender and the successful tenderer shall deposit a sum of **Rs. 5,000**/- (Rupees Five thousand only) towards **Security Deposit** (either by cash or by DD) with in two weeks from the date of commencement of work.

# Note: Project affected persons and Ex-employees of SCCL or their dependents are exempted to pay EMD.

Successful Tenderer shall be decided through draw of lottery among the applicants who wish to carryout the work as per the priorities given below.

# Eligibility: <u>Preference for awarding the contract will be given in the following order.</u>

- Project affected persons / Project displaced persons come under 1st category.
- Dependents of Ex-employees of SCCL or Ex-employees of SCCL come under 2nd category.
- > Others come under 3<sup>rd</sup> category.
- Priority will be given to 1<sup>st</sup> category persons, if not available, 2<sup>nd</sup> category persons and like wise.
- Persons fall under category 1 & 2 are permitted to deploy only one vehicle at any given point of time at any place in SCCL.
- > If the requirement of vehicles is not met with the above 1 & 2 categories then others will be given opportunity.
- In case of Project affected persons/Ex-employees or Dependents of ex-employees of SCCL the vehicle should be in the name of tenderer only.

If the tenderer is Project affected person / Project displaced person, his tender should accompany the following:

- 1. A letter duly signed by the tenderer with the following details:
  - a. Extent of land acquired
  - b. Survey no.
  - c. Village
  - d. Mandal
  - e. Award no. & date &
  - f. Purpose for which it was acquired.
- 2. Certificate from the concerned Government authorities about his identity. Eligibility of the tenderer under the above category is subject to verification of the genuineness of the details submitted by the tenderer.

If the tenderer is Ex- employee of SCCL or dependant of ex-employees, proof to that effect shall be enclosed duly signed by HOD/Personal department of concerned area.

If technically acceptable offers are received for more than the required number of vehicles, then successful Tenderers will be selected through suitable lottery system.

The SCCL reserves the right to reject any or all the tenders without assigning any reason.

**Note:** Project affected persons means project displaced persons and land ouster/ ex-Employees/dependants of ex-employees who have been allotted/ already selected for deployment of vehicles at any area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.

After completion of the tender process and placement of order, if it is found that the person is already allotted / selected for deployment of vehicle at any other area of SCCL the vehicle will be withdrawn immediately.

The SCCL reserves the right to reject any or all the tenders without assigning any reason.

- i. The tenderers are advised in their own interest to get themselves registered with the concerned statutory authorities for executing the contract with SCCL if awarded including Service Tax Registration. Any consequences arising out of non-compliance of the above, will not absolve the firm / agency from its obligations / responsibilities under the contract.
- ii. The tenderer should furnish copy of PAN No. Card and registration of the organization in their offer and clearly furnish its status whether individual / Partnership firm / Company.
