1. Applications are invited from the interested vehicle owners for Deployment of 2WD JEEP and 3T capacity platform truck on hire basis under unit rate system for a period of 3 years with a provision to extend for further 2 years, as relay orders to the existing orders. as mentioned below

- I) 11 numbers of 2WD Jeep (Non A/c) with **12 hours per day, Monthly run up-to 1000 KMs** and 30 days per month availability for various mines / departments of **SRP**.
- II) 01 number of 2WD Jeep (Non A/c) with **24 hours per day, Monthly run up-to 1000 KMs** and 30 days per month availability for **Area workshop, SRP**.
- III) 01 number 3T Cap. Platform truck with **12 hours per day, Monthly run up-to 1000 KMs** and 30 days per month availability for **Area workshop, SRP**.

To take care of revision on HSD price and Minimum wage rate, the successful tenderer will be allowed revision on pro-rata basis upward / downward at the following formula:

For 2WD Jeep & 3T PF Truck:

I) **New unit rate/month =**

Old Rate per month + [(M x (Variation in HSD Rate) x KMs Run)] + [30 x MF x 1.15 x (Variation in minimum wage per day)]

II) **-New Rate for Extra Hour:**

Old Rate for extra hour + [1.15 x Variation in minimum wages per day]/8]

III) New Rate for Extra KM:

(Old rate per extra km) + [M x (Variation in rate of HSD)]

Where,

New minimum wage rate per day for semi-skilled worker, as per circular of GM (Personnel) to be issued from time to time.

* Unit rate is calculated on base rate of Diesel @ Rs. 72.74 per liter as on 15.04.2019 at Mancherial and minimum wages of semi-skilled is Rs. 437.00 per day w.e.f. 01.10.2018 as per the GM (Per), IR, PM & RC Lr.No.CRP/PER/IR/M/361/508 dtd. 21.04.2018

Value for M = 0.07 for 2WD Jeep & Value for M = 0.13 for 3T PF Truck.

MF is 3.0 for 24 hrs availability and 1.5 for 12 hours availability.

Out station DA for driver shall be firm throughout the contract period.

The claims, if any, for the above price variation can be made once in three months. However, applicable prices will be paid in the subsequent period.

5. Processing fee is Rs. 590.00 (Rupees five hundred ninety only) per Schedule shall be paid in the form of Cash only at Cash Office, Srirampur Area and the voucher shall be submitted along with application i.e., Rs.500/- + Rs.90/- (18% GST).

6. EMD for for 2WD Jeep:

EMD Rs. 7,500/-(Rupees Seven thousand five hundred only) shall be submitted along with Tender and the successful tenderer shall deposit a sum of **Rs. 5,000/-** (Rupees Five thousand only) towards **Security Deposit** (either by cash or by DD) with in two weeks from the date of commencement of work.

EMD for for 3T PF Truck:

EMD Rs. 10,000/-(Rupees Ten thousand only) per vehicle shall be submitted along with Tender and the successful tenderer shall deposit a sum of **Rs. 5,000/-** (Rupees Five thousand only) towards **Security Deposit** (either by cash or by DD) with in two weeks from the date of commencement of work.

Note: Project affected persons and Ex-employees of SCCL or their dependents are exempted to pay EMD.

Successful Tenderer shall be decided through draw of lottery among the applicants who wish to carryout the work as per the priorities given below.

7. Eligibility: Preference for awarding the contract will be given in the following order.

- **Project affected persons / Project displaced persons come under 1st category.**

- **Dependents of Ex-employees of SCCL or Ex-employees of SCCL come under 2nd category.**
- **Others come under 3rd category.**
- **Priority will be given to 1st category persons, if not available, 2nd category persons and likewise.**
- **Persons fall under category 1 & 2 are permitted to deploy only one vehicle at any given point of time at any place in SCCL.**
- **If the requirement of vehicles is not met with the above 1 & 2 categories then others will be given opportunity.**
- **In case of Project affected persons/Ex-employees or Dependents of ex-employees of SCCL the vehicle should be in the name of tenderer only.**

If the tenderer is Project affected person / Project displaced person, his tender should accompany the following:

1. A letter duly signed by the tenderer with the following details:

- a. **Extent of land acquired**
- b. **Survey no.**
- c. **Village**
- d. **Mandal**
- e. **Award no. & date &**
- f. **Purpose for which it was acquired.**

2. Certificate from the concerned Government authorities about his identity. Eligibility of the tenderer under the above category is subject to verification of the genuineness of the details submitted by the tenderer.

If the tenderer is Ex- employee of SCCL or dependant of ex-employees, proof to that effect shall be enclosed duly signed by HOD/Personal department of concerned area.

If technically acceptable offers are received for more than the required number of vehicles, then successful Tenderers will be selected through suitable lottery system.

The SCCL reserves the right to reject any or all the tenders without assigning any reason.

Note: Project affected persons means project displaced persons and land ouster/ ex-Employees/dependants of ex-employees who have been allotted/ already selected for deployment of vehicles at any area of SCCL under unit rate system are not eligible for this enquiry and the same is to be confirmed by the applicants.

After completion of the tender process and placement of order, if it is found that the person is already allotted / selected for deployment of vehicle at any other area of SCCL the vehicle will be withdrawn immediately.
