Sealed tenders are invited by the undersigned from the registered contractors of appropriate class in The Singareni Collieries Company Limited. Contractors who have carried out works of similar magnitude only need apply. Tender schedule will be issued only to the contractors with satisfactory record of work.

1) **PRE-QUALIFICATION:** Only those contractors who are registered with S.C.Co. Ltd., in **CLASS-IV and above** are eligible to participate in the tender.

2) **Purchase of tender schedule**

The intending tenderers are required to submit application in the prescribed proforma for purchase of the tender schedule along with copy of contractor registration certificate issued by SCCL valid as on the date of opening of bids. Cost of tender schedule shall be paid in the cash office of S.C.C.L at AO (Cash) and receipt shall be presented for obtaining tender schedule. The cost of tender schedule will not be refunded to the buyer under any circumstances.

3) **Earnest Money Deposit (E.M.D):**

The intending tenderers are required to submit the EMD amount at the time of purchase of the tender schedule.

Earnest Money Deposit can be paid in the form of Crossed Demand Draft (DD)/FDR/ BG in favour of The Singareni Collieries Company Limited. In case of bank guarantees, the instruments are to be drawn on any of the Scheduled Banks notified by RBI.

If the EMD is paid in the form of Crossed Demand draft, it should be payable at KOTHAGUDEM only. D.Ds payable on outstation banks will not be accepted.

The BG submitted as per the **format** enclosed at the end of the tender document should be valid for a minimum period of **120 days** from the date of opening of price bids. On the request of SCCL, the tenderers may have to extend the validity of BGs beyond **120 days** till the tenders are finalized / contract awarded.

The Earnest Money Deposit will be refunded to all the tenderers, except the lowest tenderer within 15 days after opening of the tender / price bid.

4) **Dates for submission / opening of bids:**

a) Applications for issue of Tender Schedule will be received up to **4.00 P.M on 16.01.2019.**

b) Tender Schedules will be sold to the contractor OR through his authorised representative from the date of publication of the tender notice. Tender schedules will not be supplied by POST. Tender Schedule should be collected in person (Contractor / his authorised representative) after payment of tender cost in Cash only. Tender Schedules will be sold till **17.01.2019** up to **4.00 PM** at the office of **Dy. G. M (Civil)/KGM (A).**

- 5) a) The tenderers are allowed to submit the duly filled tenders personally OR through his authorized representative only and not by post during the working hours on any working day from the date of publication of tender notice up to the time and date as indicated below.
- b) Tender should be submitted only in tender schedule form purchased by the tenderer from the company. Offers, which are not submitted in the tender schedule form sold by the company, will be summarily rejected.
- c) The tenders will be **received up to 12.00 A.M. on 18.01.2019 and will be opened at 4.00 PM on the same date** at the office of The GENERAL MANAGER/ KOTHAGUDEM AREA.
- d) **The contractor has to tender for the work within the time. If the contractor fails to tender for the work within the time, his / their EMD will be forfeited.**
- 6) The tenderer has to keep his tender valid for **120 days** from the date of opening of the tender.
- 7) **The conditional tenders will not be accepted.**
- 8) The undersigned reserves the right to accept any tender in full **OR** in part **OR** to reject any **OR** all tenders without assigning reasons.
- 9) The successful tenderer shall submit self attested copy of PAN card and valid GST registration certificate, as the case may be, at the time of concluding the agreement.
- 10) On award of the work, if the contractor fails to execute the work within the stipulated time, or fails to show substantial progress as per the programme submitted by contractor at the time of Agreement on various items of work given in schedule of quantities, the SCCL is at liberty to order the contractor to discontinue the work forthwith and the company shall recover liquidated damages, difference in cost of the work left incomplete as per the prevailing rates, confiscate the Earnest Money Deposit & Further Security Deposits paid on the work and also to debar the contractor in participation of tenders. Such recoveries will be deducted from the bills payable to the contractor. If the amounts of pending bills are not sufficient to meet the recoveries, the SCCL is at liberty to recover from any amounts either held by SCCL or due for payment including pending bills of other works of this contractor with the SCCL.
