**NOTICE FOR AWARDING OF OUT SOURCING WORK(S)**  
**UNDER UNIT RATE TENDER SYSTEM**

The Contractors/Agencies who got registered as per S.C.C.L.'s Revised Registration System and having been **Registered under "Mutually Aided Co-operative Society (MACS)" for out sourcing works under unit rate system for Kothagudem area are only eligible to apply.**

- 1) The above work (s) will be allotted on lottery system. Application will be issued to the Agencies from the date of release of this Tender Notice to participate in Lottery system.
- 2) The eligible contractors intending to participate shall submit **Application** in the prescribed format **on or before 26-03-2025 by 4.00 PM at Office of A.G.M. (Civil) / KOTHAGUDEM AREA.**
- 3) The lottery will be conducted on **27.03.2025 at 4.00 PM** in the office of GM., Kothagudem Area among the eligible contractors.
- 4) The intending tenderers are required to submit the **Copy of Registration of MACS and copy of Identity Card** along with their Application.
- 5) The following order of preference will be followed during the lottery amongst MACS who have applied for the work.
  - i. 1 St preference to MACS of Tribal PDFs/PAFs
  - ii . 2 nd preference to MACS of Non tribal PDFs/PAFs
  - ii. 3 rd preference to MACS of Tribals of area other tan PDFs/PAFs
- 6) **The payment of Earnest Money Deposit (EMD) is exempted for participation of MACS.** The same shall be **recovered from 1<sup>st</sup> four running bills in equal installments.** EMD shall be released along with final bill.
- 7) The schedule of approximate quantities is available at the Office of A. G. M. (Civil) / KOTHAGUDEM AREA, for ready perusal.
- 8) If any MVTC training is required as per statutory, the same will be given by SCCL and the expenditure towards training including the wages to the contract labour during the training period will be reimbursed in the bills on submission of proof.
- 9) The Safety Gadgets, i.e., Helmets, Shoes etc., if required, will have to be arranged by contractor at his own cost and reimbursement will be done as per Approved Data Rates of SCCL.

- 10) The contract labour to be engaged on the work have to attend Initial Medical Examination (IME) at company Area Hospital to ascertain fitness and the expenditure on this will be reimbursed to the contractor on submission of proof.
- 11) Minimum wages as declared by Govt. from time to time are paid to the labour by the Contractor. Any enhancement in minimum wages by Government during the subsistence of the contract and its extended period will be reimbursed by the Company. The payment of minimum wages to workmen will have to be made through banks. After releasing the first month's bill, the contractor has to remit the wages in to the respective bank accounts of all the labour engaged by him on the work. For releasing payments of work done for the subsequent months, the contractor has to produce proof of having remitted the previous month's wages in to the respective bank accounts of labour engaged by him.
- 12) Payment of minimum bonus @ 8.33% of the minimum wages under Payment of Bonus Act,1965 to their workers employed by the contractors concerned.
- 13) OP/ Indoor medical treatment will be offered to the out sourcing workmen in Company's Hospitals/ dispensaries free of cost (excluding spouse or any dependents) to the extent of availability of medicines, pathological examination and other surgical treatment and they will not be allowed to get treatment in other than Company's hospital/ dispensaries (no referral cases)
- 14) The liability for payment of compensation act (as per Workmen Compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the workmen on the work and the cause of accident is not due to his negligence etc.
- 15) The contractor need not take insurance policies in the name of the labour engaged, as SCCL will reimburse the expenditure towards compensation as per Workmen composition ACT in the event of necessity.
- 16) It is mandatory for the contractor to cover Contract Labour under provision of CMPF scheme and Pension under CMP (Amendment) scheme 2018 as the case may be and it's proper implementation.
- 17) The successful Tenderer shall submit self attested copies of **PAN card** and **GST Regn. Certificate** after award of the work.
- 18) The contractor shall posses a license as required under contract labour (Regulation and Abolition) Act, 1970 and Contract labour (Regulation and Abolition) Central Rules 1971 and satisfy all the Provisions of the Act.
- 19) The Contractor has to deploy required man power for the work preferably from PDF / PAF.
- 20) The undersigned reserves the right to cancel/withdraw whole of part of the above mentioned work without assigning reasons what so ever.
