### **UNIT RATE TENDER NOTICE**

The Contractors/Agencies who got registered as per S.C.C.L.'s Revised Registration System and having been Registered under "**Mutually Aided Co-operative Society (MACS)**" for out sourcing works under unit rate system for Kothagudem area are only eligible to apply.

- The above work (s) will be allotted on lottery system. Application will be issued to the Agencies from the date of release of this Tender Notice to participate in Lottery system.
- The eligible contractors intending to participate shall submit **Application** in the prescribed format **on or before 28.09.2023 by 12.00 PM** at **Office of AGM (Civil) / KOTHAGUDEM AREA**.
- The lottery will be conducted on **28.09.2023 by 4.00 PM** in the office of SO to G M / KGM (A) among the eligible contractors.
- The intending tenderers are required to submit the **Copy of Registration of MACS and copy of Identity Card** along with their Application.
- The following order of preference will be followed during the lottery amongst MACS who have applied for the work.
  - 1 St preference to MACS of Tribal PDFs/PAFs
  - 2 nd preference to MACS of Non tribal PDFs/PAFs
  - 3 rd preference to MACS of Tribals of area other than PDFs/PAFs
- The payment of Earnest Money Deposit (EMD) is exempted for participation of MACS.** The same shall be **recovered from 1<sup>st</sup> four running bills in equal installments.** EMD shall be released along with final bill.
- If any MVTC training is required as per statutory, the same will be given by SCCL and the expenditure towards training including the wages to the contract labour during the training period will be reimbursed in the bills on submission of proof.
- The contract labour to be engaged on the work have to attend Initial Medical Examination (IME) at Company's Area Hospital to ascertain fitness and the expenditure on this will be reimbursed to the agency on submission of proof.
- The Safety Gadgets, i.e., Helmets, Shoes etc., if required, will have to be arranged by contractor at his own cost and reimbursement will be done as per Approved Data Rates of SCCL.
- The successful contractor shall start work within TWO weeks positively failing which they will not be considered for lottery for further works till the works earlier allotted are started and substantial progress is shown on the work.
- The schedules of approximate quantities are available at the Office of **AGM (Civil)/ Kothagudem Area** for ready perusal.

12. Minimum wages as declared by Govt. from time to time are paid to the labour by the Contractor. Any enhancement in minimum wages by Government during the subsistence of the contract and its extended period will be reimbursed by the Company. The payment of minimum wages to workmen will have to be made through banks. After releasing the first month's bill, the contractor has to remit the wages in to the respective bank accounts of all the labour engaged by him on the work. For releasing payments of work done for the subsequent months, the contractor has to produce proof of having remitted the previous month's wages in to the respective bank accounts of labour engaged by him
13. The tenderer should have an independent PF Code Number allotted by Assistant / Regional PF Commissioner.
14. Payment of bonus @ 8.33% of the minimum wages under Payment of Bonus Act, 1965 to their workers employed by the contractors concerned.
15. It is mandatory for the contractor to cover Contract Labour under provision of CMPF scheme and Pension under CMP (Amendment) scheme 2018 as the case may be and it's proper implementation.
16. OP/Indoor medical treatment will be offered to the contractor's workers in company's Hospital/dispensary free of cost (excluding spouse or any dependent) to the extent of availability of medicines, pathological examination and other surgical treatment. They will not be allowed to get treatment in other than company's Hospital/dispensary (no referral cases).
17. The liability for payment of compensation act (as per Workmen Compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the workmen on the work and the cause of accident is not due to his negligence etc.
18. The successful tenderer shall submit self attested copy of his PAN card/GST Registration Certificate after award of work so as the same shall be annexed to the agreement
19. The Contractor has to deploy required man power for the work preferably from PDF / PAF.
20. Contractor shall possess a license as required under Contract Labour (Regulation & Abolition) Act 1970 & Contract labour (Regulation & Abolition) Central Rules 1971 & satisfy all Provisions of the Act
21. The undersigned reserves the right to cancel/withdraw whole of part of the above mentioned work without assigning reasons what so ever.
