## NOTICE FOR AWARD OF WORKS UNDER UNIT RATE TENDERING SYSTEM

The contractors who got registered as per SCCL's Revised Registration system and having been **registered under Unit Rate System for Yellandu area only** are eligible to participate in the lottery system for the following works as per their class of Registration.

It is **mandatory** that the contractor shall submit self attested copy of his **GST** Registration Certificate, along with application.

- 1 Contractors, who have not given option and not got registered under area specific, may approach O/o GM (Civil) in person with their original registration certificate & ID card and get registered to specific area of their option before making application for participation.
- The above work(s) will be allotted on lottery system. Application will be issued to the Agencies from the date of release of this Tender Notice to participate in Lottery system.
- The eligible registered contractors intending to participate shall submit application along with EMD in prescribed format on or before 19.01.2019 by 12.00 Noon at Office of DGM(C) YA
- 4 The lottery will be conducted on 19.01.2019 at 4.00 PM in the Office of SO to GM / YA among the eligible contractors.
- The successful contractor shall start the work within **Two weeks** positively, failing which they will not be consider for lottery of further works till the works earlier allotted are started and substantial progress is shown on the works.
- Along with his / their application, Contractor(s) should submit (a) copy of Identity Card of registration in SCCL & (b) EMD amount in form of FDR (Fixed Deposit Receipt) only. The new contractor(s) to this area shall submit the copy of his / their experience certificate along with application.
- Farnest Money Deposit (EMD) shall be paid in form of **FDR only** (valid for a minimum period of 120 days from the date of draw of the tender) in favour of "The Singareni Collieries Company Limited" from any Nationalized / Sheduled banks notified by RBI, duly endorsed in favour of **SCCL**. The same should be extended by the successful tenderer for the duration of contract till EMD is refunded.
- The Earnest Money Deposit will be refunded to the unsuccessful contractors after finalization of lottery & identifying L1 contractor in the presence of the tender opening committee.
- 9 Request for adjustment of pending bills towards EMD **or** resubmission of once discharged FDR taken on other works will not be entertained.
- 10 Schedule of approximate quantities is available at Office of DGM(C) YA, for ready perusal.
- 11 The tenderer should have an independent PF Code Number allotted by Assistant / Regional PF Commissioner. It is mandatory for the contractor to cover contract labour under provision of **CMPF** Scheme **or** EPF Scheme as the case may be & its proper implementation.
- 12 The successful tenderer shall submit self attested copy of his **PAN** card after award of work so as the same shall be annexed to the agreement.
- 13 Medical facilities will be provided in SCCL hospitals to the contract labour on payment of prescribed fee & the expenditure incurred on such treatment will be reimbursed to the contractor in the bills based on the documents submitted by the contractor.

- Payment of minimum wages and Bonus @8.33% on minimum wages to workmen will have to be made through banks. After releasing the first month's bill, the contractor has to remit wages and Bonus into the respective bank accounts of all the labour engaged by him on the work. For releasing the payments of work done for the subsequent months, the contractor is to produce proof of having remitted the previous months' wages and Bonus into the
- The liability for payment of compensation (as per Workmen Compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the injured workmen on work and the cause of accident is not due to his negligence etc.
- 16 The contractor need not take **insurance** policies on the names of labour engaged, as SCCL will reimburse the expenditure compensation as per Workmen Compensation ACT in the event of necessity.
- 17 Safety Gadgets, i.e., Helmets, Shoes etc., if required, will have to be arranged by contractor at his cost and reimbursement will be done as per Approved Data Rates of SCCL.
- 18 The contract labour to be engaged on the work have to attend Initial Medical Examination (IME) at Company's Area Hospital to ascertain fitness and the expenditure on this will be reimbursed to the agency on submission of proof.
- 19 If any **MVTC** training is required as per statutory, the same will be given by SCCL and the agency has to arrange the workmen going to be deployed in mines area, work-shop, CHP etc., as per respective module. The training will be imparted at free of cost and the wages of contract labour during training period shall be to the account of agency on submission of proof.
- 20 Contractor shall possess a license as required under Contract Labour (Regulation & Abolition) Act 1970 & Contract labour (Regulation & Abolition) Central Rules 1971 & satisfy all Provisions of the Act.
