### NOTICE FOR AWARD OF WORKS UNDER UNIT RATE TENDERING SYSTEM

The contractors who got registered as per SCCL's Revised Registration system and having been registered under Unit Rate System for Yellandu area only are eligible to participate in the lottery system for the following works as per their class of Registration.

The following work was called for two times in the **ongoing cyclic system** as per the recent circular. There is no response from the eligible registered contractors of Yellandu area. Now, the work is called under **General Unit Rate System** to enable the eligible registered contractors of Yellandu area to participate. The lottery winner shall not be considered in the **ongoing cyclic system**.

- Contractors, who have not given option and not got registered under area specific, may approach O/o GM (Civil) in person with their original registration certificate & ID card and get registered to specific area of their option before making application for participation.
- The above work(s) will be allotted on lottery system. Application will be issued to the Agencies from the date of release of this Tender Notice to participate in Lottery system.
- The eligible registered contractors intending to participate shall submit application in prescribed format on or before **18.05.2022** by **5.00PM** at Office of **SE (C) YA**.
- The lottery will be conducted on **19.05.2022** at **4.00 PM** in the Office of **SO to GM / YA** in presence of the eligible contractors.
- Along with his / their application, Contractor(s) should submit **(a)** copy of Identity Card of registration in SCCL & **(b)** EMD amount in form of Fixed Deposit Receipt (FDR) only. The new contractor(s) to this area shall submit the copy of his / their experience certificate along with application.
- EMD shall be paid in form of **FDR only** (valid for a minimum period of 120 days from the date of draw of the tender) in favour of "The Singareni Collieries Company Limited" from any Nationalized / Scheduled banks notified by RBI, duly endorsed in favour of **SCCL**. The same should be extended by successful tenderer till the refunding of EMD after completion of contract.
- The EMD will be refunded to the unsuccessful contractors after finalization of lottery & identifying L1 contractor in the presence of the tender opening committee.

- 8 Request for adjustment of pending bills towards EMD **or** resubmission of once discharged FDR taken on other works will not be entertained.
- 9 Schedule of approximate quantities is available at Office of SE (Civil) YA for ready perusal.
- 10 The successful contractor shall start the work within Two weeks positively, failing which they will not be consider for lottery of further works till the works earlier allotted are started and substantial progress is shown on the works.
- 11 The tenderer should have an independent PF Code Number allotted by Assistant / Regional PF Commissioner. It is mandatory for the contractor to cover contract labour under provision of **CMPF & CMP** Schemes as the case may be & its proper implementation.
- 12 Employer's Pension contribution of 7% is applicable as per norms under **CMP** (amendment) scheme 2018.
- 13 The successful tenderer shall submit self attested copy of his **PAN** card after award of work so as the same shall be annexed to the agreement.
- 14 OP / Indoor medical treatment will be offered to the contractor's workers in company's hospitals / dispensaries at free of cost (excluding spouse or any dependent) to the extent of availability of medicines, pathological examination and other surgical treatment and they will not be allowed to get treatment in other than company's hospitals / dispensaries (no referral case).
- 15 The contract labour to be engaged on the work have to attend Initial Medical Examination (IME) at Company's Area Hospital to ascertain fitness and the expenditure on this will be reimbursed to the agency on submission of proof.
- 16 Minimum wages (with Bonus @ 8.33% on minimum wages) as declared by Govt from time to time are paid to the labour by the Contractor. Any enhancement in minimum wages by Govt during the subsistence of the contract and its extended period will be reimbursed by the Company. Payment of minimum wages to workmen will have to be made through **banks**. After releasing the first month's bill, the contractor has to remit wages into the respective bank accounts of all the labour engaged by him on the work. For releasing the payments of work done for the subsequent months, the contractor is to produce proof of having remitted the previous months' wages into the respective bank accounts of the labour engaged by him.
- 17 The liability for payment of compensation (as per Workmen Compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the injured workmen on work and the cause of accident is not due to his negligence etc.
- 18 If required, the safety gadgets like helmets, shoes, dust guard respirators etc., will have to be arranged by the contractor at his cost and reimbursement will be done as per approved data rates of SCCL.
- 19 The contractor has to make payment of minimum wages as per Notification No 180, Dt.04.04.2008 issued by Commissioner of Labour, Govt. of AP and further revisions from time to time. Any increase in minimum wages during the execution will be reimbursed by SCCL.

- 20 If any **MVTC** training is required as per statutory, the same will be given by SCCL and the agency has to arrange the workmen going to be deployed in mines area, work-shop, CHP etc., as per respective module. The training will be imparted at free of cost and the wages of contract labour during training period shall be to the account of agency on submission of proof.
- 21 Contractor shall possess a license as required under Contract Labour (Regulation & Abolition) Act 1970 & Contract labour (Regulation & Abolition) Central Rules 1971 & satisfy all Provisions of the Act.
