UNIT RATE TENDER NOTICE

1. The contractors who got registered **under new registration system as per Civil contract** Manual-2023, under Unit Rate System for RG.I Area and not awarded with any of the outsourced works in the ongoing cycle are only eligible for participation in the lottery system for the following work as per their class of Registration.

- 3. "The subject work under Unit Rate tender system is being taken up through cyclic system". Contractors registered under Unit Rate System for RG.I Area and not awarded with any of the outsourced works in the ongoing cycle are only eligible for participation
- 4. Contractors who have not given option and not got registered under area specific, may approach O/o. GM (Civil) in person with their original registration certificate and ID card and get registered to specific area of their option before making application for participation.
- 5. The intending eligible participants are required to submit the EMD amount at the time of application form. Earnest money deposit can be paid in the form of **FDR/DD/BG Only** in favour of 'The Singareni Collieries limited'. In case of Bank Guaranty, the instruments are to be drawn on any of the Scheduled Banks notified by RBI. The FDR so submitted should be valid for a minimum period of 120 days from the date of draw of the tenders. The same shall be extended by the successful tenderer for the duration of the contract till Earnest Money is refunded.
- 6. The Eligible Registered contractors intending to participate shall submit application in the prescribed format, on <u>22-11-2024</u> by 12.00 Noon at Office of S.E (Civil) RG.I.
- 7. The contractor should produce identity card and copy of registration certificate along with application.
- 8. The lottery will be conducted on <u>23-11-2024</u> at <u>3.30 PM</u> in the office of **General Manager, RG.I** among the eligible contractors.

- 9. The successful contractors shall start the work within 2 weeks positively, failing which they will not be consider for lottery for further works till the works earlier allotted are started and substantial progress is shown on the works.
- 10. The schedule of approximate quantities is available at the Office of S.E (Civil)/RG.I for ready perusal.

11. Employment of Local Persons :

- The successful bidder shall employ the local persons not less than 80% for unskilled category of work.
- ii) The successful bidder shall also give preference to local persons in skilled category and shall employ as many as possible.
- iii) Local persons means persons from PDFs, PAFs and persons belonging to local area where coal mining operations are being carried on or shall be carried on in future.

iv) First preference for employment shall be given to project Displaced families (PDFs) and Project Affected Families (PAFs) and then to other local persons.

- 12. Payment of bonus @ 8.33% of the minimum wages under Payment of Bonus Act, 1965 to their workers employed by the contractors concerned.
- 13. It is mandatory for the contractor to cover contract labour under provision of CMPF Scheme and Pension under CMP (Amendment) scheme 2018 as the case may be and it's proper implementation.
- 14. Medical facilities will be provided in SCCL hospitals to the contract labour at free of cost.
- 15. The liability for payment of compensation (as per Workmen Compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the injured workmen on the work and the cause of accident is not due to his negligence etc.
- 16. The successful tenderer shall submit self attested copy of PAN card after award of the work.
- 17. The payment of minimum wages to workmen will have to be made through banks. After releasing the first month's bill, the contractor has to remit the wages in to the respective bank accounts of all the labour engaged; by him on the work. For releasing payments of work done for the subsequent months, the contractor has to produce proof of having remitted the previous months wages into the respective bank accounts of labour engaged by him.

- 18. The contract labour to be engaged on the work have to attend Initial Medical Examination (**IME**) at Company's Area Hospital to ascertain fitness at free of cost.
- 19. If any MVTC training is required as per statutory, the same will be given by SCCL and the agency has to arrange the workmen going to be deployed in mines area, work-shop, CHP etc., as per respective module. The training will be imparted at free of cost and the wages of contract labour during the training period will be reimbursed in the bills against submission of documentary proof.
- 20. The successful tenderer shall submit copy of GST registration /PAN card at the time of concluding the agreement.
- 21. Contractor shall possess a license as required under Contract Labour (Regulation & Abolition) Act 1970 & Contract labour (Regulation & Abolition) Central Rules 1971 & satisfy all Provisions of the Act.
