- 1. The Contractors who are registered under Unit Rate System for <u>RG.I Area</u> are only eligible to apply. Contractors who have not given option and not got registered under area specific, may approach O/o. GM(Civil) in person with their original registration certificate and ID card and get registered to specific area of their option before making application for participation.
- 2. The intending eligible participants are required to submit the EMD amount at the time of application form. Earnest money deposit can be paid in the form of Fixed Deposit Receipt (FDR) only. The Earnest Money Deposit can be paid in the form of FDR duly endorsed in favour of SCCL. The FDR so submitted should be valid for a minimum period of 120 days from the date of draw of the tenders. The same shall be extended by the successful tenderer for the duration of the contract till Earnest Money is refunded.
- 3. The Eligible Registered contractors intending to participate shall submit application in the prescribed format, on <u>22-09-2020</u> by 12.00 Noon at Office of Dy.General Manager (Civil) RG.I.
- 4. The contractor should produce identity card and copy of experience certificate of works carried out.
- 5. The lottery will be conducted on <u>24-09-2020</u> at 4.00 PM in the **office of General** Manager, RG.I among the eligible contractors.
- 6. The successful contractors shall start the work within 2 weeks positively, failing which they will not be consider for lottery for further works till the works earlier allotted are started and substantial progress is shown on the works.
- 7. The class-IV contractors will be eligible to participate Unit Rate System for works up to Rs.5.00 Lakhs only and for works more than Rs.5.00 Lakhs Class-IV contractors will not be allowed.
- 8. The schedule of approximate quantities is available at **the Office of DGM(Civil)/RG.I** for ready perusal.
- 9. The contractor / bidder should have an independent P.F code Number allotted by Asst/Regional commissioner.

- 10. Payment of bonus @ 8.33% of the minimum wages under Payment of Bonus Act,1965 to their workers employed by the contractors concerned.
- 11. It is mandatory for the contractor to cover contract labour under provision of CMPF scheme and Pension under CMP (Amendment) scheme 2018 as the case may be and it's proper implementation.
- 12. Medical facilities will be provided in SCCL hospitals to the contract labour at free of cost.
- 13. The liability for payment of compensation (as per Workmen Compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the injured workmen on the work and the cause of accident is not due to his negligence etc.
- 14. The successful tenderer shall submit self attested copy of PAN card after award of the work.
- 15. The payment of minimum wages to workmen will have to be made through banks. After releasing the first month's bill, the contractor has to remit the wages in to the respective bank accounts of all the labour engaged; by him on the work. For releasing payments of work done for the subsequent months, the contractor has to produce proof of having remitted the previous months wages into the respective bank accounts of labour engaged by him.
- 16. The contract labour to be engaged on the work have to attend Initial Medical Examination (IME) at Company's Area Hospital to ascertain fitness and the expenditure on this will be reimbursed to the agency on submission of proof.
- 17. If any MVTC training is required as per statutory, the same will be given by SCCL and the agency has to arrange the workmen going to be deployed in mines area, work-shop, CHP etc., as per respective module. The training will be imparted at free of cost and the wages of contract labour during training period shall be to the account of agency on submission of proof.
- 18. The contractors/Tenderers should invariably quote its CST/GST/VAT registration Number under Sales Tax Act, otherwise the Company has right to reject the application / tender summarily.
- 19. Contractor shall possess a license as required under Contract Labour (Regulation & Abolition) Act 1970 & Contract labour (Regulation & Abolition) Central Rules 1971 & satisfy all Provisions of the Act
