Sealed tenders are invited by the undersigned from the registered contractors of appropriate class in The Singareni Collieries Company Limited. Contractors who have carried out works of similar magnitude only need apply.

**I. PRE-QUALIFICATION:**

- i) Only those contractors who are registered with S.C.Co. Ltd., in appropriate class are eligible to participate in the tender.
- ii) The registered contractors intending to participate, shall submit application in the Prescribed format at the office of DGM (C) RG-II area, 8 Incline colony, Godavarikhani.
- iii) Earnest Money Deposit (EMD) can be paid in the form of Crossed Demand Draft (DD)/ FDR / BG in favour of 'The Singareni Collieries Company Ltd.' In case of Bank Guaranty, the instruments are to be drawn on any scheduled banks notified by RBI.
- iv) If the EMD is paid in the form of Crossed Demand draft, it should be drawn on any Nationalized Bank/Scheduled Bank and payable at Godavarikhani/Ramagundam only. D.Ds payable on outstation banks will not be accepted.
- v) The contractor should produce Identity Card and copy of experience certificate of works Carried out along with the application.
- vi) **The contractor shall submit his GST registration certificate along with his application.**

**II. E.M.D**

- i) The EMD shall be 2.50% of the estimated cost **(Part 'A' + Part 'B')**. 1% EMD as mentioned in the table above shall be paid in the form of DD/FDR along with the tender schedule while submitting the sealed tender.
- ii) The successful tenderer should pay balance 1.50% E.M.D in the form of **DD/FDR/BG** at the time of concluding the agreement.

### III TENDERING PROCEDURE:

1. The bidder shall submit copy the following documents while submitting the application for obtaining tender schedule .
  - a) Contractor registration certificate issued by SCCL valid as on the date of opening of bids.
  - b) EMD instrument.
2. **The Price Bid is provided in 2 parts.**

Part 'A' contains Schedule of quantities and rates for Cement & Steel to be issued by SCCL on Sale Invoice. Bidder is not allowed to quote for this and hence not uploaded on e-procurement.

Bidders are requested to go through special clauses provided in Part 'A'

Part 'B' contains schedule of quantities and rates for other construction items and uploaded on e-procurement to enable the bidders to quote their uniform percentage on this.
3. The ceiling of tender premium shall be 5% for Part 'B'.
4. **Dates for submission of applications / receipt / opening of tender bids is as follows:**
  - (a) Last date for submission of application for obtaining Tender schedule upto 12.00 Noon on : **03-03-2021.**
  - (b) Last date for Submission of sealed tenders upto **04-03-2021** up to 4.00 P.M.
  - (c) The tenders will be opened at 4.30 P.M. on **04-03-2021** , at the Office of **General Manager/Rg-II.**
6. The Tenderer has to keep his tender valid for 120 days from the date of opening of tenders.
7. **The successful tenderer shall submit copy of GST registration certificate/ PAN card at the time of concluding the agreement.**

### IV. OTHER INFORMATION TO THE BIDDER:

1. If any successful bidder fails to submit the above within the stipulated time, they will be suspended from participating in the tenders on procurement for a period of **three years.**
2. **Tender schedule will be issued at free of cost.**
3. **Conditional tenders will not be accepted.**
4. **Price Adjustment Clause: Price adjustment clause detailed elsewhere in the tender document is not applicable.**
5. The undersigned reserves the right to accept any tender in full or in part or to reject any or all tenders without assigning reasons.

6. On award of the work, if the contractor fails to execute the work within the stipulated time, or fails to show substantial progress as per the programme submitted by contractor at the time of Agreement on various items of work given in schedule of quantities, the SCCL is at liberty to order the contractor to discontinue the work forthwith and the company shall recover liquidated damages, difference in cost of the work left incomplete as per the prevailing rates, confiscate the Earnest Money Deposit & Further Security Deposits paid on the work and also to debar the contractor in participation of tenders. Such recoveries will be deducted from the bills payable to the contractor. If the amounts of pending bills are not sufficient to meet the recoveries, the SCCL is at liberty to recover from any amounts either held by SCCL or due for payment including pending bills of other works of this contractor with the SCCL.
