The Contractors who got registered themselves as per SCCL's Revised Registration system are only eligible to participate in the lottery system for the following works as per their class of registration.

- Vide circular no: CRP/CVL/OTS/2025-26/954 DT: 02.04.2025 competent authority has communicated revised penalty clause in case of absenteeism of Contractors workmen, in civil out sourcing tenders with immediate effect and incorporating the following clause.

 - Not to impose penalty, if the absenteeism is upto 25% of scheduled manpower to be deployed per day. However, proportionate quantum of work (i.e., out-turn of the individual/ absentee in terms of equivalent Area/Volume of the respective activity) shall be deducted from payments payable to contractor.*
 - If the absenteeism (partial) is more than 25% of scheduled manpower to be deployed per day,*
 - penalty @ Rs 300/- per day over and above 25% absenteeism on daily basis and*
 - proportionate quantum of work (i.e., outturn of the individual/ absentee in terms of equivalent Area/Volume of the respective activity) shall be deducted from payments payable to contractor.*
 - In case of full absenteeism: If it is found that the work entrusted is not totally carried out on any particular day/days, a proportionate amount per day from contractual amount will be deducted as the case may be depending upon the number of days in the calendar month. In addition, 50% of such arrived amount will be deducted as fine.*
- "The subject work under Unit Rate System is being taken up through cyclic system". Contractors registered under Unit Rate System for RG-III Area and not awarded with any of the outsourced works in the ongoing cycle are only eligible for participation".**
- Contractors who are registered under Unit rate system for RG.III Area are only eligible to apply. Contractor's who have not given option and not got registered under Area specific, may approach O/o GM (C) in person with their original registration certificate and ID card and get registered to specific

4. The registered contractors intending to participate shall submit application in the prescribed format on **14.08.2026 by 12.00 PM** at the office of DGM(C) RG-III along with EMD in the form of **FDR** duly endorsed in favor of "SCCL" payable at Godavarikhani from Nationalized Bank. **The contractor shall submit his GST registration certificate along with his application.**
5. Earnest Money Deposit (EMD) can be paid in the form of Crossed Demand Draft (DD)/ FDR / BG in favor of 'The Singareni Collieries Company Ltd.' In case of Bank Guaranty; the instruments are to be drawn on any scheduled banks notified by RBI.
6. If the EMD is paid in the form of Crossed Demand draft, it should be drawn on any Nationalized Bank/Scheduled Bank and payable at Godavarikhani/Ramagundam only. D.Ds payable on outstation banks will not be accepted.
7. The contractor should produce Identity Card Carried out along with the application. The lottery will be conducted **on 15.08.2026 at 4.00 PM** in the office of GM, RG-III among the eligible contractors.
8. The successful contractor has to renewal his registration as per new Civil Contract Manual 2023 prior to execution of agreement.
9. The successful contractor shall start work within TWO weeks positively, failing which they will not be considered for lottery for further works till the works earlier allotted are started and substantial progress is shown on the works.
10. The schedule of approximate quantities is available at the Office of DGM(C), RG III for ready perusal.
11. The payment of minimum wages to workmen will have to be made through Banks. After releasing the first month's bill, the contractor has to remit the wages into the respective bank accounts of all the labour engaged by him on the work. For releasing payments of work done for the subsequent months, the contractor has to produce proof of having remitted the previous months wages into the respective bank accounts of labour engaged by him.
12. OP/Indoor medical treatment will be offered to the contractor's workers in company's Hospital/ dispensary free of cost (excluding spouse or any dependent) to the extent of availability of medicines, pathological examination and other surgical treatment. They will not be allowed to get treatment in other than company's Hospital/dispensary (no referral cases).
13. The liability for payment of compensation (as per workmen compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the injured workmen on work and the cause of accident is not due to his negligence etc.
14. The contractor / tenderer should invariably quote his GST Registration number. Otherwise company has right to reject the application / tender immediately.
