1. The work will be allotted on lottery system.
2. The contractors who got registered themselves as per SCCL revised registration system are only eligible to participate.
3. The last date for submission of application along with EMD is up to 12.00 Noon on **25.02.2019**.
4. The draw will be conducted on **27.02.2019** at 4.00 P.M. in the chamber of SO to G.M/RG-III.
5. Earnest Money Deposit to be paid in the form of Fixed Deposit Receipt only (FDR). The Earnest Money Deposit can be paid in the form of FDR from any of the Scheduled banks notified by RBI, duly endorsed in favour of Singareni Collieries Company Limited.
6. FDRs so submitted should be valid for a minimum period of 120 days from the date of conducting Lottery of the tender as indicated in Para No.4 above. The same shall be extended by the successful tenderer for the duration of contract till Earnest Money is refunded.
7. Request for adjustment of pending bills towards Earnest Money or re-submission of once discharged FDR taken on other works will not be accepted.
8. The Earnest Money Deposit will be refunded to the unsuccessful contractors after finalization of lottery & identifying successful tenderer in the presence of the tender committee.
9. The successful contractor shall submit Rs.100/- Non-judicial stamp paper for entering agreement with the SCCL and start work within two weeks positively failing which they will not be considered for lottery for further works till the works earlier allotted are started.
10. The schedule of approximate quantities is available at the office of Dy.General Manager (Civil), Ramagundam-III for ready perusal.
11. The contractor/bidder should have an independent PF code number allotted by Asst/Regional P.F. Commissioner.
