I. PRE-QUALIFICATION:

1. Only those contractors who are registered with S.C.Co. Ltd., in appropriate class are eligible to participate in the tender.

Civil Contract Manual-2023 has come in to force w.e.f. 20.09.2023. The existing registered contractors have to renew their registration as per new registration system on or before 19.03.2024.

During the transition period i.e., up to 19.03.2024, existing registered contractors will be allowed for participation in the tenders with the revised tender eligibility values of respective class. In case of L1 bidders, who will be awarded with the work within the transition period, shall renew their registration under new registration system prior to execution of Agreement.

II. Earnest Money Deposit(E.M.D)

i) The EMD shall be 2.50% of the estimated cost for performance of contract. Initial EMD (1% of estimated cost), as mentioned in the table above shall be paid online along with the tender using Net banking/ RTGS/ NEFT from their registered bank accounts (or) using Credit Card/ Debit Card as per the VISA/ MASTER Card guidelines (or) in the form of BG.

ii) 1% Earnest Money Deposit can be paid in the form of DD/FDR/ BG. If the EMD is paid in the form of **Crossed Demand draft**, it should be payable at **Godavarikhani** only. In case of **FDR**, it should be drawn from **banks on account of S.C.Co.Ltd**

iii) In case **bank guarantees**, the instruments are to be drawn on any of the **Scheduled Banks notified by RBI**. The BG submitted as per the **format** enclosed at the end of the tender document should be valid for a minimum period of **120 days** from the date of opening of price bids. On the request of SCCL, the tenderers may have to extend

iv) If the successful tenderer has paid 1% amount online, the balance 1.50% amount for performance of contract to be paid in the form of DD/FDR/BG at the time of concluding the agreement (or) if the successful tenderer has paid 1% initial amount in the form BG at the time of bidding, the tenderer has to pay total 2½% amount duly replacing the Bank Guarantee for 1% EMD paid already at the time of bidding in the form of DD/FDR/BG. In case of Bank Guarantee, the same is to be drawn from Public sector Bank/Private Bank incorporated in India having net worth of Rs.5,000 crores and above for the previous financial year

III. TENDERING PROCEDURE:

1. The bidder shall scan and upload the following documents while participating in the tender
 - a) Contractor registration certificate issued by SCCL valid as on the date of opening of bids.
 - b) EMD instrument.
2. Price bid contains schedule of quantities and rates blank for items and uploaded on e-procurement to enable the bidders to quote their rate per man shift on this.
3. The price bids of the bidders who have submitted the above documents will be opened on the specified date. In case of extension of the date of opening of bids, suitable corrigendum will be published in the e-procurement platform
4. **Dates for submission / opening of bids:**
 - (a) Tender documents can be down loaded from 04.00 P.M. on **22.02.2024**.
 - (b) Last date for Submission of Bids is **07.03.2024** up to 4.30 P.M.
 - (c) The **Price Bids** will be opened at 5.00 P.M. on **07.03.2024**, at the Office of **Deputy General Manager (Civil)/RG-III**.
5. The Tenderer has to keep his tender valid for **120 days** from the date of opening of price bids.
6. The successful tenderer shall submit self attested copy of PAN card at the time of concluding the agreement.

IV. OTHER INFORMATION TO THE BIDDER:

1. **Submission of hard copies of the documents & original E.M.D. instruments:**

The Department will notify the successful bidder for submission of hard copies of registration certificate and original EMD at time of bidding.

Further after award of work, the 2½ % EMD for performance of contract is to be submitted (replacing 1% EMD paid at the time of bidding) and to be kept valid for a period of 15 months.
2. If any successful bidder fails to submit the above within the stipulated time, they will be suspended from participating in the tenders on procurement for a period of **three years**.
3. **e-Procurement Transaction Fee:**

The participating bidder should pay e-procurement Transaction Fee @ 0.03% on the estimated contract value of the work subject to prevailing ceiling amounts with GST online.

Further, successful bidder has to pay e-procurement corpus fund at 0.04% of Estimated Contract Value of the work subject to prevailing ceiling amounts before entering in to the agreement. However, there will not be any charges towards e-procurement fund in case of works with ECV less than and up to Rs.10 Lakhs.
4. **Conditional tenders will not be accepted.**
5. **Price Adjustment Clause:** Price adjustment clause is not applicable for this work.
6. The undersigned reserves the right to accept any tender in full or in part or to reject any or all tenders without assigning reasons.

7. On award of the work, if the contractor fails to execute the work within the stipulated time, or fails to show substantial progress as per the programme submitted by contractor at the time of Agreement on various items of work given in schedule of quantities, the SCCL is at liberty to order the contractor to discontinue the work forthwith and the company shall recover liquidated damages, difference in cost of the work left incomplete as per the prevailing rates, confiscate the Earnest Money Deposit & Further Security Deposits paid on the work and also to debar the contractor in participation of tenders. Such recoveries will be deducted from the bills payable to the contractor. If the amounts of pending bills are not sufficient to meet the recoveries, the SCCL is at liberty to recover from any amounts either held by SCCL or due for payment including pending bills of other works of this contractor with the SCCL.
8. The contract labour engaged should have VTC training certificate as per norms.
9. The work is to be carried out in underground mine. The intending bidders are requested to inspect the location before quoting the tender.
10. The contract labour that are stipulated by mine authorities should report for duty in all the 3 shifts at Man way of the mine and to work in underground mine as advised by mine authorities.
11. The agency shall provide safety appliances to all his employees such as miner's safety shoes and miner safety belts etc: and ensure that they put in to use as required under law
12. The agency should quote rate including bonus @ 8.33% on each man shift and pay to the contractor's labour.
