1. For participation the registered contractors intending to participate shall submit application in the prescribed format on or before **07.07.2020** up to 12.00 noon at the office of Dy.G.M (Civil)/ BPA, HQ. Goleti along with the EMD.
2. The contractor should produce identity card and copy of experience certificate of works carried out by him and submit copies of same along the with the application.
3. Lottery will be conducted on **09.07.2020** at 4.00 pm in the office of GM / Bellampalli area, HQ. Goleti in the presence of available eligible contractors.
4. Earnest Money Deposit can be paid in the form of Crossed Demand Draft (DD)/FDR/ BG in favor of The Singareni Collieries Company Limited .In case of bank Guaranty ,the instruments are to be drawn on any of the Scheduled banks notified by RBI.
5. The FDRs/DDs, so submitted should be valid for a minimum period of 4 months from the date of opening of tender as indicated in Para No.4 the same shall be extended by successful tenderer for the duration of contract till Earnest Money is refunded.
6. Request for adjustment of pending bills towards Earnest Money OR resubmission of once discharged FDRs taken on other works will not be accepted.

7. The successful contractor shall start work within two weeks positively failing which they will not be considered for lottery for further works till the works earlier allotted are started. The successful contractor should deploy the Tribals /PDFs /PAFs of the area to the extent available.
8. The class-1V Contractors will be eligible to participate in unit rate System for the works up to Rs.5.00 lakhs, class-III up to Rs.20.00 lakhs, class-II up to Rs.40.00, Class-I up to- Rs.100.00 lakhs & Special class above-Rs.100.00 lakhs as per civil contract manual.
9. The schedule of approximate quantities is available at the office of Dy.G.M (Civil)/ BPA Area HQ: Goleti for ready perusal.
10. The contractor/tenderer should invariably quote his CST/GST/Registration number under the sales tax act. Otherwise company has right to reject the application/tender summarily.
11. The contractor/Bidder should have an independent PF code number allotted by Asst/Regional PF. Commissioner.
12. Minimum wages as declared by Govt. from time to time are paid to the labour by the contractor. Any enhancement in minimum wages by Govt. During the subsistence of the contract and its extended period will be reimbursed by the company. The payment of minimum wages to workmen will have to be made through banks. After releasing the first month's bill the contractor has to remit the wages in to the respective bank accounts of all the labour engaged by him on the work. For releasing payments of work done for the subsequent months, the contractor has to produce proof of having remitted the previous month's wages in to the respective bank accounts of labour engaged by him.
13. It is mandatory for contractor to cover contractor labour under provision of CMPF scheme and it's proper implementation.
14. The medical facilities will be provided in SCCL hospitals to the contract labour on payment of prescribed fee and the expenditure incurred on such treatment will be reimbursed to the contractor in the bills based on the documents submitted by the contractor.
15. The liability for payment of compensation Act (as per workmen compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the workmen on the work and the cause of accident is not due to his negligence etc.

16. The successful tenderer shall submit copy of GST registration certificate/PAN card at the time of concluding the agreement.
17. The contractors who are registered under unit rate system for Bellampalli area are only eligible to apply. Contractors who have not given option and not got registered for Bellampalli area specific may approach O/o GM (Civil) in person with their original registration certificate and ID card and get registered to Bellampalli area as their option before applying.
18. The undersigned reserves the right to cancel/withdraw whole of part of the above mentioned work without assigning reasons what so ever.
19. It is mandatory for the contractor to cover contract labour under provision of CMPF scheme or EPF scheme as the case may be and its proper implementation. (Vide Ref.No CRP/PER/IR/C/086/583 Dt: 09.05.2020 Percentage of Employee's contribution (Pension 7% + CMPF 12% =19%) and percentage of Employer's Contribution (Pension 7% + CMPF 12% + Administrative charges 0.72% =19.72%)).
