П. E.M.D :

The EMD shall be 2.50% of the estimated cost (Part 'A' + Part 'B'). For this work EMD is exempted for participation in the tender & for concluding the agreement by successful contractor. However, required EMD of 2.5% of the estimated cost (Part A+ Part B) shall be recovered from the running bills after expenditure of 25% of

the concerned work.
