- 1) The Registered Contractors intending to participate shall apply in the prescribed format along with the EMD on or before 18-02-2019 by 12.00 Noon at the office of Deputy General Manager (Civil)/SRIRAMPUR, Mancherial (Dist), Pin-504 303
- 2) The lottery will be conducted on 19-02-2019 at 4.00 PM at the office of General Manager /SRIRAMPUR, Mancherial (Dist), Pin-504303 in the presence of tender committee members & the eligible contractors who are present at that time.
- 3) The intending eligible participants are required to submit the EMD amount at the time of application form, Earnest money Deposit can be paid in the form of Fixed Deposit Receipt (FDR) duly endorsed in favour of SCCL payable at Srirampur from Nationalized Bank.
 - i) Earnest Money deposit can be paid in the form of Crossed Demand draft (DD)/FDR/BG in favour of The Singareni Collieries Company Limited. In case Bank Guarantees, the instruments are to drawn on any of the Scheduled Banks notified by RBI.

- 4) FDRs, so submitted should be valid for a minimum period of 120 days from the date of draw of the tenders as indicated in Para No. 2 above. The same shall be extended by the successful tenderer for the duration of contract till earnest Money is refunded.
- 5) Request for adjustment of pending bills towards Earnest Money OR re-submission of once discharged FDR taken on other works will not be accepted.
- 6) The Earnest Money Deposit will be refunded to the un-successful tenderers after finalization of lottery & identifying lottery winner in the presence the tender opening committee.
- 7) The contractor should produce identity card and copy of experience certificate of works carried out by him and submit copies of the same along with application.
- 8) The successful contractor shall enter into agreement with SCCL within Two weeks from the date of award of work and start the work within 2 weeks positively, failing which they will not be considered for lottery for further works till the works earlier allotted are started.
- 9) The class-IV contractors will be eligible to participate in Unit Rate System for works up to Rs.5 Lakhs only, as per the Civil Contract Manual and for works more than Rs.5.00 Lakhs class-IV contractors will not be allowed.

- 11) The Successful tenderer shall submit self attested copy of PAN card after award of the work.
- 12) Minimum wages as declared by Govt. from time to time are paid to the labour by the contractor. Any enhancement in minimum wages by Govt. during the subsistence of the contract and its extended period will be reimbursed by the company.
- 13) OPD/Indoor medical treatment will be offered to the out sourcing workmen in Company's Hospitals/ dispensaries free of cost (excluding spouse or any dependents) to the extent of availability of medicines, pathological examination and other surgical treatment and they will not be allowed to get treatment in other than Company's hospital/ dispensaries (no referral cases.

- 14) The liability for payment of compensation act (as per Workmen Compensation Act) to the contract labour for personal injury caused by accident arising out of and in the course of employment will rest on SCCL. However, the contractor has to produce necessary documentary evidence of having engaged the workmen on the work and the cause of accident is not due to his negligence etc.
- 15) The successful tenderer shall submit copy of GST registration certificate/Pan card at the time of concluding the Agreement.
- 16) The successful tenderer has to pay wages of workers through banks by 7th of every month Otherwise action will be initiated as per terms and conditions of the contract.
- 17) Estimated cost for One year period will be considered to assess the eligibility of the contractor for this work.
