## **UNIT RATE TENDER NOTICE**

The contractors who got registered as per SCCL's registration system to participate in Unit Rate tenders identified for MACS for the tenders called by Civil Department at STPP area are eligible to participate in the lottery system for this tender. The minimum strength of the MACS society shall not be less than 15. Lottery will be conducted among the eligible MACS. The successful contractor should make all his workmen & staff as the member of EPF & ESI. Contractors who have not given option and not got registered under area specific, may approach O/o GM (Civil) in person with their original registration certificate and ID card and get registered to specific area of their option before making application for participation in the lottery system for the following work.

**"The work under unit rate tender system is being taken up through cyclic system by giving 1st preference to MACS of tribal PDFs/PAFs then to MACS of non tribal PDFs/PAFs and then to MACS of tribals of the area other than PDFs/PAFs tribals."**

1. The eligible MACS (Mutually Aided Co-Operative Society) intending to participate shall submit application in the prescribed format along with the EMD on or before **12.07.2025** by **12.00** Noon to **The DGM (Civil) :STPP , Jaipur, (V&M), Mancherial District, PIN-504 216.**
2. The lottery will be conducted on **12.07.2025** at **4.00 PM** at **The DGM (Civil): STPP, Jaipur (V&M), Mancherial District, PIN-504 216** in the presence of tender committee members & the eligible contractors who are present at that time.
3. The intending tenderers are required to submit the **Copy of Registration of MACS (Mutually Aided Co-Operative Society) and copy of Identity Card** in case of MACS (Mutually Aided Co-Operative Society) along with their Application.
4. **The payment of Earnest Money Deposit (EMD) is exempted for registered MACS (Mutually Aided Co-Operative Society).** The same shall be recovered from 1<sup>st</sup> four bills in equal installments from the successful MACS (Mutually Aided Co-Operative Society). EMD shall be released along with final bill.

5. The contractor should comply with all statutory provisions applicable from time to time. The contractor shall opt for **EPF & ESI** for all his workmen and staff as the members of **EPF & ESI**. A copy of the monthly subscription towards EPF & ESI contribution shall be submitted to Accounts department of STPP.
6. The details of present **EPF & ESI** contribution to be followed are furnished here under for compliance. However any change in the employer's contribution rates will be reimbursed by SCCL during the contract period.

7. The payment of minimum wages and **Bonus @ 8.33% on the minimum wages** to workmen will have to be made through banks. For releasing payments of work done for the subsequent months, the contractor has to produce proof of having remitted the previous month's wages and **Bonus** into the respective bank accounts of labour engaged by him.
8. The wages and **Bonus** of the employees shall be paid before the expiry of the 7<sup>th</sup> day of every month after last day of the wage period in respect of which wages and **Bonus** are payable.
9. In addition to the above, a certificate shall be issued by the concerned official that the contractor has deducted that amount of EPF & ESI and deposited along with the matching share with the concerned EPF & ESI authorities and a copy of the certificate shall be attached with the bill of the contractor.
10. Payment to the contractor shall be released against the bill by the Finance Department, STPP after verifying the above documents.
11. If any MVTC training is required as per statutory, the same will be given by SCCL and the expenditure towards training including the wages to the contract labour during the training period will be reimbursed in the bills on submission of proof.
12. The contract labour to be engaged on the work have to attend Initial Medical Examination (IME) at company Area Hospital at free of cost.
13. The contractor should produce identity card copy along with application.
14. The successful contractor shall enter with SCCL agreement within Two weeks from the date of award of work and start the work within 4 weeks from letter of award, failing which they will not be considered for lottery for further works till the works earlier allotted are started.

15. The schedule of approximate quantities is available at **The DGM (Civil): STPP, Jaipur (V&M), Mancheria District, PIN-504 216** for ready perusal.
16. The required safety gadgets i.e., helmets, Shoes etc., have to be arranged by the contractor and the expenditure will be reimbursed as per the rates in SCCL outsourcing manual.
17. The successful tenderer shall submit copy of GST registration certificate and self-attested copy of PAN card after award of the work.
18. Minimum wages as declared by Govt. and **payment of bonus @ 8.33% of the minimum wages to his workers under the payment of Bonus Act, 1965** from time to time are paid to the labour by the contractor. Any enhancement in minimum wages by Govt. during the subsistence of the contract and its extended period will be reimbursed by the Company.
19. Successful tenderer has to obtain labour license from the concerned Government department for the labour to be deployed on the work and fees if any, remitted to Government for obtaining the labour license will be reimbursed on submission of proof of payment.
20. Estimated cost for one year period will be considered to assess the eligibility of the contractor for the work shown above.
21. **Employment of local persons:**
  - (a) The successful bidder shall employ the local persons not less than 80% for unskilled category of work.
  - (b) The successful bidder shall also give preference to local persons in semi skilled & skilled category and shall employ as many as possible.
  - (c) Local persons means persons from PDFs, PAFs and persons belonging to local area of STPP.
  - (d) First preference for employment shall be given to Project Displaced Families (PDFs) & Project Affected Families (PAFs) and then to other local persons.
