**NOTE (\*)** There is every possibility of increase/decrease of the quantity of Eucalyptus clones to be supplied as per demand.

1. The tender shall be in two parts namely Technical bid and Price bid. Technical bid shall contain documents in support of EMD and other relevant documents. In price bid, the bidders should quote their rates as listed above and as per format given in e-portal. **The bidders who qualify in the Technical Evaluation only will be considered for price bid evaluation**, on approval of competent authority.
2. Interested bidders should participate by uploading relevant documents in e-portal and EMD as mentioned shall be paid online or by Challana generation through any Nationalized bank in favour of The Singareni Collieries Company Limited, Kothagudem. The EMD submitted shall be valid for the entire tender period of the contract from the date of opening of the tender.

3. The tenderers are allowed to submit their bids from the date of publishing of the tender notice till **3.00 PM on 24-04-2019**. The **Technical Bid (Part-I)** of the tender will be opened on the same day *i.e.*, on **24-04-2019 at 4.00 PM** and price bid will be opened on **26-04-2019 at 4.00 pm** in the Office of Addl.G.M (Forestry), Kothagudem Corporate.
4. The bidder shall upload all the required documents / certificates/ statements. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.
5. Technical bid will be opened on the due date. The price bid of only those bidders, who are found qualified in technical bid will be opened after technical evaluation. The date of opening of price bid mentioned is only indicative date. In case of any extension of last date for submission of bids / date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform.
6. The Earnest Money Deposit will be refunded through e-portal to the unsuccessful tenderer only after finalization of the L1 tenderer.
7. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
8. The Company employees should not participate in tenders either directly or indirectly.
9. Before quoting the rates, the bidders are advised to go through the NIT, Terms & Conditions thoroughly. Bidders shall quote their rate in the online format for each item of work.
10. Though registration certificate is shown as mandatory in documents required screen, it is not applicable for this work.
11. Though possessing of turnover, liquid assets/ Credit facilities is shown as mandatory in eligibility criteria screen, the same is not applicable for this work.

17. All the taxes will be borne by the bidder like *viz*; GST, IT , TCS, etc., from time to time as applicable.
18. Notwithstanding to anything stated above, The Singareni Collieries Company Limited reserves the right to assess the capability and capacity of intending bidders to perform the contract.

**Special conditions:**

- a) The Eucalyptus clones have to be supplied to other than SCCL areas (*i.e.*, different areas in the Telangana State) (4000000 Nos.).
- b) The Supplies are to be carried out in a phased manner as per the requirement by SCCL in the given tender period, the agency should carry out the works accordingly.
- c) **“The suppliers should have experience in supplying at least 20 Lakh Nos.of good quality Eucalyptus clones to any Govt. /PSU firms/units during last 2 years” (Original proof of experience to be enclosed).**
- d) **Supply order documents with respect to the experience certificate.**
- e) **Payment vouchers/bank statements related to the supplies made.**
- f) The Successful bidder at the time of entering into this Agreement has to pay equal to 5% of the total value, towards the Security Deposit for the supply of the Eucalyptus clones which has to be paid towards security depot prior to commencement of work or entering into agreement whichever is earlier.
- g) The General terms and conditions furnished in the tender will also be applicable wherever it is deemed fit for the supply of the required Eucalyptus clones.

## GENERAL TERMS AND CONDITIONS

### **1.0 SCOPE OF WORK:**

1.1 **Provision of labour and implements:** This contract includes all labour, material, tools, implements and every other things necessary for carrying out and completing the works in conformity with the plans and specifications (herewith attached), descriptions and instructions as may from time to time be furnished while the work is in progress.

### **2.0 TENDER OFFERS:**

2.1 The tenderer shall submit the offer only in the prescribed tender schedule issued to him. No alterations (additions or deletions) shall be made to the tender schedule, conditions of contract, specifications, schedule of approximate quantities *etc.* Offers submitted in any other form (other than schedule issued to them) shall be summarily rejected.

2.2 Tenderers must quote their rate both in WORDS and FIGURES. In case of any discrepancy between the words & figures, the words shall prevail. No further correspondence in this regard will be entertained.

2.3 The rate quoted shall be firm till completion of contract

2.4 The tender shall be valid for FOUR MONTHS from the date of opening of tender.

2.5 Information on the following is to be furnished along with the tender.

- a) Names and addresses of the partners/directors, if the tenderer is a Partnership firm/company
- b) Banker's names and addresses and
- c) Income tax permanent account number
- d) Full and correct postal address with pin code *etc.*, to which all communications should be sent. The responsibility to receive promptly all the communications sent to him rests fully on tenderer himself.

2.6 The tender will be treated as incomplete, if

- a. The tenderer fails to quote his rate on the Company's estimated rates or his own rate, as the case may be for all parts or Part of the tender schedule.
- b. Any of the over writings, corrections, alterations in the rate quoted are not attested by the tenderer with full signature.
- c. the tender is not accompanied by the EMD.

2.7 Incomplete tenders will be rejected out-right and no further representation in this regard will be entertained.

2.8 Conditional tenders will not be accepted.

3.0 SCCL reserves the right to negotiate with L1 tenderer.

4.0 If the L1 tenderer backs out of the contract, Company has got the right to negotiate with L2 tenderer.

5.0 SCCL reserves the right to accept or reject any tender or all tenders without assigning any reasons thereof.

6.0 **AGREEMENT BOND:** Once the tender is accepted and award letter is issued, the successful tenderer shall execute an agreement with the company on Non-judicial stamp paper of Rs.100/- with in 10 (ten) days from the date of award letter or before the commencement of work, whichever is earlier.

## **7.0 DEPOSITS:**

### **7.1 Earnest Money Deposit (EMD) :**

- 7.1.1 EMD @ 5% of estimated value or the amount as indicated in the tender schedule should be paid at the time of submitting the filled in tender schedule.
- 7.1.2 EMD can be paid in the form of F.D.R. / Demand Draft / Bankers Cheque duly endorsed in favour of The Singareni Collieries Company Limited payable at Kothagudem. The DD/FDR should be valid for the entire period of contract.
- 7.1.3 The EMD of the unsuccessful tenderers will be refunded after tender opening.
- 7.1.4 The EMD amount of the successful tenderer shall be released only after satisfactory completion of contract period.

### **7.20 Security Deposit (SD):**

- 7.2.1 In addition to the EMD paid at the time of submitting the tender, the successful tenderer has to pay the Security Deposit (SD) amount at 5% of tender value. The amount has to be paid before commencement of the work/before concluding the agreement, which ever is earlier in through DD /FDR/Banker's Cheque.
- 7.2.2 Security Deposit amount will be released in the final bill.
- 7.3 Request for adjustment of pending bills amount, EMD, SD of the other works of the company towards EMD & SD of this tender will not be accepted.
- 7.4 No interest will be paid on the EMD or SD deposited with the Company.

## **8.0 CONTROL OF WORK:**

- 8.1 The works are to be conducted under the sole control and direction of Advisor (Forestry) or his authorized representative. The whole of materials are to be of the best description of their respective kinds and both workmanship and materials shall be of good quality.  
The Contractor shall when required, furnish satisfactory evidence of the quality of materials he is supply.
- 8.2 Everything necessary including materials, labour, tools, equipment, and transportation is to be provided and paid for, by the contractor, so that the work may be completed and perfect at its conclusion, to the entire satisfaction of the Advisor (Forestry) or his authorized representative, who shall have power to reject any materials or labour during the progress of work which he may deem improper or to remove any person in the Contractor's employment, of whom he may disapprove, and the contractor is to supply alternate material or labour which shall meet the approval of the Advisor (Forestry) or his authorized representative.
- 8.3 The Contractor shall furnish for approval all samples as directed. The work shall be in accordance with the tender schedule.
- 8.4 The contractor shall keep each one copy of all specifications of the work in good order available at site

## **9.0 EXECUTION OF WORK:**

- 9.1 The successful tenderer shall complete the supply within the stipulated time and as per specifications prescribed in the tender document. The Nos. to be supplied may be changed, modified or altered by the Area/ Regional Forest officer, as and when necessary based on the requirements.
- 9.2 The contractor shall also seek the directions from the Area Forest Officer from time to time for commencing the supply of material and complete the same with in the prescribed time.

- 9.3 The contractor should inform immediately about the date of commencement of the supply in writing to the Area Forest Officer without any delay.
- 9.4 The contractor or his agent duly authorized by him should present at site whenever required during the supply of material.
- 9.5 The Company shall not be responsible for any compensation of losses or damages incurred by the contractor.
- 10.0** The contractor at his/her own cost make/form and maintain whatever temporary arrangements, that he may require for bringing any material or equipment to the work, or arrange for hutment or camping of his labour and staff including sanitation of the locality and no extra charge will be allowed or paid by the SCCL on account of any such arrangements.
- 11.0** The Company shall not be responsible for any accident occurring to his workmen or any other person during the progress of the work. The company will not be liable to pay the compensation to the workmen employed in the execution of work by the contractor under Workmen Compensation Act. The contractor should also comply with all safety regulations as per the Mines Act in force.
- 12.0** Company shall not pay any compensation what so ever towards idleness of contractor's labour and equipment *etc.*
- 13.0** The Contractor shall continuously maintain adequate protection of all his work from damage and shall protect the owner's property from damage or loss arising in connection with the contract. He shall make good such damages or loss except such as caused by agents, or employees of the owner in the interests of the Company. He shall provide and maintain all facilities for protection, as required by local condition
- 14.0 SUB-CONTRACTS:** No work forming part of this contract work is to be subleased by the Contractor.
- 15.0 CORRELATION WITH OTHER AGENCY OR CONTRACTOR:** During the period of contract, if any special jobs are required to be done through any other agency or through the department, the Contractor will have to co-ordinate his activities with those of the other agency or department.
- 16.0 INSPECTION OF WORKS:** The Advisor(Forestry) and his authorized representative shall at all times have access to the work whether it is in preparation or progress and the contractor shall provide proper facilities for such, access and for inspection. Inspections required by the specifications shall be promptly made by the Advisor (Forestry) or his authorized representative and where practicable at the source of supply.
- 17.0 ALTERATIONS AND ADDITIONS TO WORK:** The Advisor (Forestry) or his authorized representative with out invalidating the contract, may order extra supplies or make changes by altering, adding to or deducting from the supplies, the payment on this account being adjusted accordingly. All such supplies will be executed under the conditions of the original contract except that any claim for extension of time caused there by shall be adjusted at the time of ordering such a change.  
Claim for such an extra supply or change shall however be supported by a written order, from the Advisor (Forestry) or his authorized representative.  
The value of such extra supply or change by way of addition or deduction shall be determined on the basis of tendered rates of the contractor applicable to actual measurements as certified by the authorized representative of the Advisor (Forestry).

**18.0 DEDUCTIONS FOR UNCORRECTED WORK:** If the Advisor(Forestry) or his authorized representative deem it expedient to correct supply which is not done in accordance with contract, value of the work as determined by the shall be made from the Contractor's bills.

**19.0 MEASUREMENT OF WORK:**

- 19.1 The quantities indicated for the purpose of calling tenders is only approximate and therefore the payment will be restricted to the actual quantities after due measurements.
- 19.2 The contractor shall attend joint inspection of the supply being carried out by him whenever required by the Company authorities.
- 19.3 Measurement of the supply done will be made according to the progress of the supply and the same shall be valued according to the awarded rates.

**20.0 MEASUREMENTS, PAYMENTS, ADVANCE AND DEPOSITS:**

- 20.1 Measurements of the supply will be made as per payment schedule or later according to the progress of the supply, by the authorized representative of the Advisor(Forestry) or his staff, and the same will be valued according to the schedule of rates.
- 20.2 The contractor shall not be entitled to interest upon any payment, in arrears or upon and balance which may on the final settlement of his account be found due to him.
- 20.3 All applicable Central and State Government taxes and royalties and works contract taxes will be deducted at source as per the direction of the Government from time to time from the bills of the contractor.
- 20.4 If the executed quantities exceed the estimated quantities, payment shall be restricted to the approved quantities and payments for the excess quantities will be released after due approval of the competent authority.
- 20.5 Amounts due to the company from the contractor, if any will be recovered from the contractor's running or final bills or any amounts due from the company.

**21.0 TIME WITHIN WHICH CONTRACT IS TO BE COMPLETED:**

- 21.1 Time is essence of the contract.
- 21.2 The contractor shall satisfactorily execute and complete the supply in strict accordance with the plans, specifications enclosed herewith and instructions issued by Advisor(Forestry) or his authorized representative from time to time and execute the supply within the period as per the schedule of operations given by the Company for completing various items of work given in schedule of quantities.
- 21.3 If the contractor fails to execute the supply within the stipulated time or fails to show substantial progress as per the schedule of operations given by the Company in schedule of quantities, the SCCL is at liberty to order the contractor to discontinue the supply forthwith and to get the balance supply executed at reasonable rates through any other agency but at the contractor's cost and also to recover liquidated damages from the contractor's bills.
- 21.4 If the contract be delayed at any time in progress of the supply by any act or cause beyond the contractor's control or by delay authorized by the Advisor(Forestry) or his authorized representative, then the time of completion shall be extended for such reasonable time as the Advisor(Forestry) or his authorized representative may decide.

- 22.0 OWNER'S RIGHT TO DO WORK:** If the contractor neglects to execute the supply properly or fail to perform any provision of this contract, the Advisor(Forestry) or his authorized representative after one day written notice to the contractor may, without prejudice to any other remedy he may have, make good such deficiencies and may deduct the cost thereof from the payment, due to the Contractor (provided that the Advisor(Forestry) or his authorized representative shall approve both such action and the amount charged to the contractor).
- 23.0 OWNER'S RIGHT TO TERMINATE CONTRACT:** If the contractor fails to abide by the conditions of contract, if he should persistently disregard the instructions of the Advisor(Forestry) or his authorized representative or if he should be adjudged bankrupt or if he should make a general assignment for the benefit of his creditor, then the Advisor(Forestry) without prejudice to any other right of remedy and after giving the contractor Seven days written notice, terminate the contract and take possession of the premises and of all materials *etc.*, and finish the work by whatever method he may deem fit. The Contractor will be responsible for all losses and damages incurred by the SCCL in this respect.
- 24.0** The Advisor(Forestry) also reserves the right to terminate the contract at any stage or suspend the supply without assigning reasons if in his opinion, it is considered necessary to do so. On receipt of such notice the Contractor shall submit within 24 hours of receipt of the notice at site a complete list of his commitments for settling the same by the company within a period of one month. The Advisor(Forestry) may allow up to a maximum of 7 days after issue of the notice for continuing the work to enable using up by the Contractor as far as possible the materials at site or in transit.
- 25.0 BRIBES ETC.** The Contractor or any one on his behalf shall not canvas, pay, give or offer reward of gratuity to any employees of S.C.Co.Ltd., or else the Advisor(Forestry) will be at liberty to cancel the contract and forfeit the EMD lodged with his tender.
- 26.0** Company employees should not participate in the tenders either directly or indirectly. If it is found at a later stage that the contractor is a Company employee, the contract will be terminated by forfeiting his deposits and all the money due in performance of the works besides initiating disciplinary proceedings as per Company's standing orders.
- 27.0 LIQIDATED DAMAGES FOR LATE EXECUTION :**The supplies have to be carried out strictly as per schedule and executive instructions given by Area Forest Officer. For any non-performance/delay in execution of the supply, the contract will be terminated by forfeiting his deposits and withholding the payments to the extent the work is sub-standard or incomplete. SCCL shall arrange for completion of balance supplies by engaging an alternate contractor/ other source at the risk and cost of the contractor. Any additional cost incurred by the SCCL in this respect will be recovered from the pending bills of the original contractor. In such case, the original contractor will be debarred/blacklisted from participating in the future works in the company.



## **28.0 SETTLEMENT OF DISPUTES:**

Any dispute or difference of opinion arising between the Advisor(Forestry) or his authorized representative and the contractor in respect of the quality, specifications, measurements, manner of executing or anything connected with the supply, not specially provided for herein under the specifications or in respect of the meaning of any clause of these General conditions shall be adjudicated by the arbitrator nominated by C&MD., of SCCL for the disputes costing up to Rs.50,000/- and shall be binding on all parties without any reference or appeal to any other person whatever. However, the claims above Rs.50,000/- in value shall be decided by 'CIVIL COURT' of competent jurisdiction and not by arbitration.

The parties raising the dispute shall request the C&MD of the Company to nominate an Arbitrator. If C&MD of the company does not nominate an arbitrator within one month of receipt of notice, the arbitration agreement automatically lapses. The parties have to approach 'CIVIL COURT' of competent jurisdiction for deciding the claims.

## **29.0 DETAILED SPECIFICATIONS & SPECIAL CONDITIONS FOR SUPPLY OF EUCALYPTUS CLONES.**

29.1.1 The Eucalyptus clones should be between 25-45 Cms height (and never >45 Cms height) and should be healthy with active growing tips and free from gall, little leaf and other infestations.

29.1.2 The Eucalyptus clonal plants should be supplied along with stands on support.

29.1.3 The suitable Eucalyptus clones shall be supplied as per the requirement of the Area Forest Officer.

29.1.4 The Eucalyptus clones should be supplied to the respective areas as per the requirement of the area Forest Officer concerned.

29.1.5 The cost of the clonal material including loading, transportation to the site, unloading *etc.*, Transit losses or damages to the plants shall have to be born by the contractor.

29.1.6 The payments will be made only to those number of Eucalyptus clones accepted by the respective Area Forest Officer concerned to whom the clones has been supplied.

29.1.7 The quantity may be increased or decreased as per the field conditions.

29.1.8 It is the agencies responsibility to take back the returnable materials (*i.e.*, trays and tubets) as soon as the planting is completed with the proper acknowledgement from the Area Forest Officer.

29.1.9 The clonal plants shall be replaced by the contractor up to 5% of the original quantity of supply, as casuality replacements.

29.1.10 Supply period of the Eucalyptus clonal plants will last from the day of issue of the supply order and may be extended or reduced if required.

30.0 In the event of breach of any of the conditions at any time, the supply order may be withdrawn summarily by the authority competent to sanction the supply with out any compensation to the supplier.

30.1.1 Tender from Tenders black listed/debarred by any Government or Semi-Government body will be out rightly rejected.

30.1.2 Withdrawal or amendments in the offered bid will not be entertained under any circumstances and shall lead to forfeiture of the Earnest Money Deposit (EMD).

30.1.3 The supplier will supply high quality Eucalyptus clonal plants as per the specification of the Tender Document, in such quantities as may be requested by the Area Forest Officer from time to time for use in Forestry Department of SCCL. The supplier binds himself/herself not to violate any of the conditions laid down in the tender document during the period of validity of the supply order.

- 30.1.4 The tenderer will be fully responsible in every respect to the quality and specifications as well as the quality of Eucalyptus clonal plants to be supplied. In case of any dispute regarding quality/quantity of Eucalyptus clonal plants, the decision of the Advisor (Forestry) shall be final and binding on the contractor.
- 30.1.5 Delivery schedule of Eucalyptus clonal plants to various areas shall be communicated to the successful bidder. The supplier shall strictly adhere to the supply schedule and also to any additional conditions laid down in the supply order or thereafter.
- 30.1.6 Payment will be made on delivery of the goods at destination subject to the satisfaction of the respective Area Forest Officers w.r.t. quality and quantity of the material.
- 30.1.7 The supplier will be responsible for damage or loss in transit and replace Eucalyptus clonal plants damaged within 20 days from the date of notice thereof.
- 30.1.8 Conditions as to terms for performance whether laid down herein or in any indent shall always be regarded as the essence of the supply order.
- 30.1.9 The Area Forest Officer or any other officer duly authorized in writing by him, or his superior authority, shall have the power to inspect the supply, before, during or after production, loading, collection, dispatch, transit or arrival and to reject the same or any part or portion, if he or they be not satisfied with the quality of the supply to be supplied by the tenderer/contractor w.r.t specifications mentioned in the Tender Document.
- 30.1.10 The contractor shall not change or be paid for supplies rejected as above and such supplies shall be removed by the supplier at once at his expense. He shall neither claim nor be entitled to payment for any damage that he may suffer on account of defective supplies incidental to a full and proper examination and test of such supplies. The Area Forest Officer/the authority competent to sanction the contract shall be under no liability whatever for rejected supplies and the same will be at the contractor's risk.  
Rejected supplies shall be removed by the contractor within 10 days after notice has been issued to him of such rejection, failing which the Area Forest Officer may charge the contractor rent for the space occupied by such rejected goods.
- 30.1.11 Supplier will submit the bills/invoices in duplicate duly verified from concerned Area Forest Officer against the number of Eucalyptus clonal plants supplied to various areas of SCCL and other than SCCL areas (*i.e.*, different areas in the Telangana State) during the month. He/she will also enclose the detailed statement regarding number of Eucalyptus clonal plants (Clone wise) supplied to each Area/Division with the date of receipt of the Eucalyptus clonal plants in the field along with bills/invoices.
- 30.1.12 On receipt of such bills and verification of these bills by various Area Forest Officers regarding receipt of the Eucalyptus clonal plants, payments to supplier will be released from time to time.
- 30.1.13 On the failure of the supplier to make supply within the extended period on receipt of such information in the office of the Area Forest Officer risk purchase at the cost of supplier may be made by the Area Forest Officer. The difference of cost thus incurred will be recovered from the supplier in a suitable manner, and even from the pending bills or security whichever is available.
- 30.1.14 No payments will be made in advance for any supplies under this contract.
- 30.1.15 **“The suppliers should have experience in supplying at least 20 Lakh Nos.of good quality Eucalyptus clones to any Govt./PSU firms/units during last 2 years”.** (Original proof of experience to be enclosed).
- 30.1.16 **Supply order documents with respect to the experience certificate.**
- 30.1.17 **Payment vouchers/bank statements related to the supplies made.**

**31.0 DEFINITIONS.**

- 30.1 The contract documents consist of the General Conditions of Contract, the Drawings and specifications including all modifications thereof incorporated in the documents before their execution and the programme of work. These form the contract.
- 30.2 The contractor and the Advisor(Forestry) or his authorized representatives are those mentioned are treated throughout the contract documents as if each were of the singular member.
- 30.3 Written notice shall be deemed to have been duly served if delivered in person to the individual or to member of the Firm or to an officer of the corporation for whom it is intended or if delivered to or sent by registered post to the last business address known to him who gives the notice.
- 30.4 The term "Work/supply" of the contractor includes labour or material or both.
- 30.5 All the time limits stated in the Contract Documents are of the essence of the contract.
- 30.6 The existing laws in the area where the contract work is undertaken will be applicable to the Contractor.
- 30.7 "Company" or S.C.Co.Ltd., means, the Singareni Collieries Company Limited, P.O. Kothagudem Collieries represented by the Advisor (Forestry).
- 30.8 Advisor(Forestry) means the officer Employed by the Singareni Collieries Company Limited, Forestry department of The Singareni Collieries Company Limited.
- 30.9 Authorized representative of the Advisor (Forestry) means the Area Forest Officer or any other officer nominated by the Advisor (Forestry).
