1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD. The **Price Bids (Part-II)** of the bidders who qualify in the Technical Evaluation only will be considered, and accepted to open, on approval of competent authority. In price bid, the bidders should quote **AT PAR with estimated rates** only and tenderer should confirm their acceptance on SCCL tender schedule. **Please quote ATPAR only, the agencies quoted less/more than the estimated rate will be rejected and not considered for the lottery.**
2. **All the interested agencies without any experience criteria shall participate in the above tender by paying EMD in e-portal by online or by Chalan generation through any Nationalized bank in favor of The Singareni Collieries Company Limited, Corporate. The EMD submitted shall be valid for the entire period of the contract from the date of opening of the tender.**
3. The tenders are allowed to submit the bids from the date of publishing till **03.00 PM on 07.03.2026**. The **Technical Bid (Part-I)** of the tender will be opened on the same day *i.e.*, on **07.03.2026 at 04.00 PM** and price bid will be opened on **09.03.2026 at 04.00 PM** in the Office of GM(ENV & Forestry-FAC), Kothagudem Corporate.

4. The bidder shall scan and upload all the required documents / certificates/ statements. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.
5. Technical bid will be opened on the due date. The price bid of only those tenderers, who are found qualified in technical bid will be opened after technical evaluation of the bids is completed. The date of opening of price bid mentioned is only indicative date. In case of any extension of last date for submission of bids / date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform.
6. **Lottery will be drawn among the tenderers whose offers are technically qualified and quoted ATPAR under Unit rate lottery system and the winner will be declared as successful tenderer.**
7. The Earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalization of the L1 tenderer.
8. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
9. The Company employees should not participate in tenders either directly or indirectly.
10. The proposed quantity in the estimate are only tentative, they may increase or decrease subject to field requirement.
11. Before participation in the tenders, the bidders are advised to go through the NIT, Terms & Conditions, Estimate thoroughly. Bidders shall quote in the online format as **AT PAR** with estimated value (**Unit Rate system**).
12. The successful bidder will be finalized among the qualified bidders by drawing a lottery.
13. The wages are to be paid directly to the workers through a bank account by the contractors.
14. A uniform penalty of Rs.300/- will be imposed towards absenteeism of each man day (irrespective of number of days of absence).
15. **Employment of local persons:**
  - i) The successful bidder shall employ the local persons not less than 80% for unskilled category of work.
  - ii) The successful bidder shall also give preference to local persons in skilled category and shall employ as many as possible.
  - iii) Local persons means persons from PDFs, PAFs and persons belongings to local area where coal mining operations are being carried on or shall be carried on in future.
  - iv) First preference for employment shall be given to Project Displaced Families (PDFs) & Project Affected Families (PAFs) and then to other local persons.
16. Though registration certificate is shown as mandatory in documents required screen. The same is not applicable for this work.

17. Though possessing of turnover, liquid assets/ Credit facilities is shown in the as mandatory in eligibility criteria screen. The same is not applicable for this work also the parameters.
18. In the PQ stage, the bidders need not submit data for following parameters in the given format.
  - a. Key critical equipment
  - b. Previously executed works
  - c. Work done as a prime contractor
  - d. Key personnel
  - e. Works on hand / Tendered details
  - f. Eligibility criteria.
19. The successful tenderer shall deploy minimum manpower as per the estimate and ensure payment of latest minimum wages circular by G.M.(PER) IR & PM through banks including CMPF, EPS, Bonus, ESI and all statutory provisions circulated time to time.
20. The successful tenderer shall provide wage slips, medical books, uniform etc.,
