Tender for transportation of timber from Government Timber depot of Bayyer, Garra, Kanki, Pathriganj, Lanta & Langi depots of North and South Balaghat circle, Madhya Pradesh to Srirampur timber yard of SCCL is invited **among all the experienced timber transport agencies/contractors to carry out the transportation work in e-procurement mode (double cover system).**

1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD, Copy of experience certificate, Copies of RC books, documentary evidence of Lorries available to him from other owners on non-judicial stamp paper. In price bid, **the bidders should quote their rate per cubic meter of timber** as per format given in e-portal. The bidders who qualify in the Technical Evaluation only will be considered for price bid evaluation, on approval of competent authority.
2. Experienced contractors/bidders should participate by uploading documents like **EMD, Copy of experience certificate, Copies of RC books, documentary evidence of Lorries available to him from other owners on non-judicial stamp paper in e-portal.**

3. The EMD as mentioned shall be paid online or by Challana generation through any Nationalized bank in favour of **The Singareni Collieries Company Limited, Kothagudem.** The EMD submitted shall be valid for the entire tender period of the contract from the date of opening of the tender.
4. The tenderers are allowed to submit the bids from the date of publishing the tender notice till **3.00 PM on 21.08.2025.** The Technical Bid (Part-I) of the tender will be opened on the same day *i.e.*, on **21.08.2025 at 4.00 PM** and price bid will be opened on **23.08.2025 at 4.00 PM** in the Office of GM(Env & Forestry-FAC) Kothagudem Corporate.
5. The bidders shall scan and upload all the required documents / certificates/ statements
 - a) Name of the directors/partners, if the tenderer is a limited company or a partnership firm.
A copy of the partnership deed/registration shall be uploaded to the tender.
 - b) Bankers name and address,
 - c) Income Tax permanent Account number with copy of the PAN card,
 - d) GST registration No./TIN No.
 - e) **Copies of RC books (i.e., valid RC documents specifying validity period of the vehicles), documentary evidence of Lorries available to him from other owners on non-judicial stamp paper (Mandatory).**
 - f) Full and correct postal address with PIN code, e-mail id, to which all communication should be sent,
 - g) **Copy of work experience (Mandatory).**
The documents with respect of the experience certificate should be uploaded in the e-portal for technical scrutiny of the bids. The agency shall have experience of transporting a minimum of 500 Cum of timber successfully to any Government /PSUs in any of the preceding 3 financial years, i.e., 2022-23, 2023-24 & 2024-25.
 - h) **EMD as mentioned in the NIT shall be paid online through any Nationalized bank in favour of The Singareni Collieries Company Limited, Kothagudem. (Mandatory).**
6. The bidder is liable to be disqualified and blacklisted and EMD will be forfeited, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.

7. Technical bid will be opened on the due date. The price bid of technically qualified bidders will be opened for further evaluation. The date of opening of price bid mentioned is only indicative date. In case of any extension of last date for submission of bids/date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform.
8. For Successful tenderers, **The EMD will be converted to Security Deposit (SD), which will be refunded after successful completion of the work.**
9. The Earnest Money Deposit will be refunded to the unsuccessful bidder immediately after finalization of the L1 tenderer.
10. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever and tenderer shall have no authority to claim any damages or compensation as a result of such action.
11. The SCCL has got the right to fix more than one agency for the work.
12. **The rate quoted by the contractor shall be on firm-price basis subject to Price variation Clause on account of diesel price hike during the period of contract. The rate should be inclusive of loading at the depot site, unloading and stacking at Company timber yard, all the applicable taxes (except service tax) and all incidental expenses enroute. The work shall be executed as per the terms and conditions.**
13. The Company employees should not participate in tenders either directly or indirectly.
14. Before quoting the rates, the bidders are advised to go through the NIT document along with Terms & Conditions. **The Bidders should quote their transport rate per cubic meter of timber in the online format given in e-portal.**
15. Though registration certificate is shown as mandatory in documents required screen. The same is not applicable for this work.
16. Though possessing of turnover, liquid assets/ Credit facilities is shown in the as mandatory in eligibility criteria screen. The same is not applicable for this work also the parameters.

18. The Conditional tenders will not be accepted.
19. The intending tenderers are advised to inspect the areas personally before participating in the tenders.

20. All the taxes will be borne by the bidder like viz; GST, IT, TCS, etc., from time to time as applicable.
21. The transportation works are carried out as per the time schedule/quantities purchased by SCCL at Government timber depots/places as mentioned in the NIT in the given tender period and the agency should carry out the works accordingly.
22. The quantity available at Government timber depots have been assessed approximate quantities only and they may vary as per the availability of timber at the concerned depots.
23. The Successful bidder should enter into Agreement with SCCL for the transportation of timber from awarded depot to Srirampur timber yard of SCCL for a period of 1 year from the date of award.
24. Notwithstanding to anything stated above, The Singareni Collieries Company Limited reserves the right to assess the capability and capacity of intending tenderers to perform the contract.
25. The work is to be carried out as per the terms and conditions attached herewith.
26. The General terms and conditions furnished in the tender will also be applicable wherever it is deemed fit for the timber transport work.
