“Supply of 50,000 No’s of fruit bearing plants of 4 feet height for Kothagudem area during the year 2025-26 procurement mode (2 cover system). Please quote your rate Per plant including transportation cost i.e. FOR destination basis.

1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD. In price bid, the bidders should quote their rates as listed above and as per format given in e-portal. **The bidders who qualify in the Technical Evaluation only will be considered for price bid evaluation**, on approval of competent authority.
2. Interested bidders should participate by uploading relevant documents in e-portal along with the EMD as mentioned shall be paid online or by Challana generation through any Nationalized bank in favour of The Singareni Collieries Company Limited, Kothagudem. The EMD submitted shall be valid for the entire period of the contract from the date of opening of the tender.
3. The tenders are allowed to submit the bids from the date of publishing the tender notice till **03.00 PM on 18.07.2025**. The **Technical Bid (Part-I)** of the tender will be opened on the same day *i.e.*, on **18.07.2025 at 04.00 PM** and price bid will be opened on **19.07.2025 at 04.00 pm** in the Office of GM(Env & Forestry - FAC), Kothagudem Corporate.

4. The bidder shall upload all the required documents / certificates/ statements. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.
5. Technical bid will be opened on the due date. The price bid of only those tenderers, who are found qualified in technical bid will be opened after technical evaluation of the bids is completed. The date of opening of price bid mentioned is only indicative date. In case of any extension of last date for submission of bids / date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform.
6. The Earnest Money Deposit will be refunded through e portal to the unsuccessful tenderer only after finalization of the L1 tenderer.
7. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
8. The Company employees should not participate in tenders either directly or indirectly.
9. Before quoting the rates, the bidders are advised to go through the NIT, Terms & Conditions, Estimate thoroughly. Bidders shall quote their rate in the online format for each item of work, i.e. Rate contract system
10. Though registration certificate is shown as mandatory in documents required screen, it is not applicable for this work.
11. Though possessing of turnover, liquid assets/ Credit facilities is shown as mandatory in eligibility criteria screen, the same is not applicable for this work.
12. In the PQ stage, the bidders need not submit data for following parameters in the given format.
 - a) Key critical equipment
 - b) Previously executed works
 - c) Work done as a prime contractor
 - d) Key personnel
 - e) Works on hand / Tendered details
 - f) Eligibility criteria.

14. The Conditional tenders will not be accepted.
15. The cost of the plant material including loading, transportation to the site, unloading *etc.*, Transit losses or damages to the plant material shall have to be borne by the supplier.

16. All the taxes will be borne by the bidder like viz; GST, IT , TCS, etc., from time to time as applicable.
17. Notwithstanding to anything stated above, The Singareni Collieries Company Limited reserves the right to assess the capability and capacity of intending tenderers to perform the contract.
18. The General terms and conditions furnished in the tender will also be applicable wherever it is deemed fit for the plants supply work.

Special conditions:

- a) The fruit bearing plants have to be supplied to Kothagudem area, SCCL.
- b) The Supply of plants shall be done as directed by the I/C Forestry officer of Kothagudem area, SCCL in the given tender period (One month).
- c) The plant shall have well established graft free from disease/pest attack with healthy growing tips
- d) The plants/grafts that are converted recently into bigger bags will not be accepted.
- e) The graft/layers should be healthy, vigorous and free from pest and diseases.
- f) The average height of the seedlings should be minimum 4 feet height and bag size as mentioned.
- g) All the applicable taxes should be born by you only.
- h) Payment will be made within 30 days after receipt of total quantity of plants or one intermediate payments will be made on the request of agency to the extent of supply of plants.
