Tenders are invited by the undersigned from interested bidders for the following works in e-procurement mode (2 cover system):

- 1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD and other relevant documents if any. In price bid, the bidders should quote their rates as listed above and as per format given in e-portal. The bidders who qualify in the Technical Evaluation only will be considered for price bid evaluation, on approval of competent authority.
- 2. Interested bidders should participate by uploading relevant documents in e-portal along with the EMD as mentioned shall be paid online or by Challana generation through any Nationalized bank in favour of The Singareni Collieries Company Limited, Kothagudem. The EMD submitted shall be valid for the entire period (3Months) of the contract from the date of opening of the tender.
- 3. The tenderers are allowed to submit the bids from the date of publishing the tender notice till **03.00 PM on 25.04.2024**. The **Technical Bid (Part-I)** of the tender will be opened on the same day *i.e.*, on **25.04.2024 at 4.00 PM and** price bid will be opened on **28.04.2024 at 4.00 PM** in the Office of AGM(Forestry), Kothagudem Corporate.
- 4. The bidder shall upload all the required documents / certificates/ statements. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.
- 5. Technical bid will be opened on the due date. The price bid of only those tenderers, who are found qualified in technical bid will be opened after technical evaluation of the bids is completed. The date of opening of price bid mentioned is only indicative date. In case of any extension of last date for submission of bids / date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform.
- 6. The Earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalization of the L1/H1 tenderer.
- 7. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
- 8. The Company employees should not participate in tenders either directly or indirectly.

- 9. Before quoting the rates, the bidders are advised to go through the NIT, Terms & Conditions, Estimate thoroughly. Bidders shall quote their rate in the online format for each item of work.
- 10. Though registration certificate is shown as mandatory in documents required screen. The same is not applicable for this work.
- 11. Though possessing of turnover, liquid assets/ Credit facilities is shown in the as mandatory in eligibility criteria screen. The same is not applicable for this work.
- 12. In the PQ stage, the following parameters also not applicable for this work
 - a. Key critical equipment
 - b. Previously executed works
 - c. Work done as a prime contractor
 - d. Key personnel
 - e. Works on hand / Tendered details
 - f. Eligibility criteria.
- 13. The O/o.DGM (Forestry), Corporate may be contacted for more details. Phone No.08744-235990.
- 14. The Conditional tenders will not be accepted.
- 15. The intending tenderers are advised to inspect the areas personally before participating in the tenders.
- 16. All the taxes will be borne by the bidder like *viz*; GST, IT, TCS, etc., from time to time as applicable.
- 17. Notwithstanding to anything stated above, The Singareni Collieries Company Limited reserves the right to assess the capability and capacity of intending tenderers to perform the contract.

Special conditions:

- 1. Before quoting the rate the agency shall inspect the site of proposed work.
- 2. No alteration shall be made in the tender schedule
- 3. The quantities given in the tender schedule are tentative and they may increase (or) decrease in view of field conditions.
- 4. The quoted rates will remain firm till the completion of contract/during the period of contract.
- 5. All relevant licenses and permits for felling and transportation of miscellaneous timber shall be taken by the bidder only and relevant charge/fees if any shall be borne by the bidder only. The rate will remain firm till completion of work/during the period of contract.
- 6. The work should be executed within 3 months from the date of commencement.
- 7. No tree/timber other than those shown by the Area Forest Officer or his representative shall be felled/lifted.
- 8. All the felled material should be cut into required sizes.
- 9. No timber should be carried outside from the felling area without proper documents issued by the Company.
- 10. The contractor should bring his own tools and implements.
- 11. All the standing growth or felled material should be protected by the contractor. Any theft or loss of material due to negligence in protection measures will attract the penalty of upto 5 times the market value of the produce as decided by the competent authorities.
- 12. All the material loaded into the vehicles at the plantation site (Bamboo poles) should be handed over at the destination without any damage or loss to the material and proper acknowledgement from the receiving stores should be submitted for getting payment.

- 13. The felling works are carried out in a phased manner as per the requirement of props by SCCL in the given tender period (3months), the agency should carryout the works accordingly.
- 14. The quantities of Bamboo poles have been assessed based on ocular estimation only and they may vary while executions i.e., increase/decrease as per the field conditions. The contractor should bound to complete the work in all the plantation areas of Kothagudem area within the tender period and also as per the instructions given by the Incharge Officer from time to time.
- 15. The agency should make all necessary arrangements for complete protection of entire material in the site till the completion of the works in all respects, failing which the penalties should be imposed on the agency if any.

16. Payment terms:

- (i) For Felling, Conversion and transportation works: Payment will be made based on the progress of work and final payment will be made to the agency after satisfactory completion.
- 17. The General terms and conditions furnished in the tender will also be applicable wherever it is deemed fit for felling and extraction of props/chock timber and also for transportation/disposal of pulpwood & firewood works.
