Tender is invited by the undersigned for the following works in **e-procurement mode** among the interested bidders.

1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD etc. In price bid, the bidders should quote their uniform percentage on the estimated value of the work. The **Price Bid (Part-II)** of the bidders who qualify in the Technical Evaluation only will be considered, and accepted to open, on approval of competent authority.
2. Eligible bidders should participate by uploading relevant documents in e-portal along with the EMD as mentioned shall be paid online or by Chalan generation through any Nationalized bank in favor of The Singareni Collieries Company Limited, Kothagudem. The EMD submitted shall be valid for the entire period of the contract from the date of opening of the tender.
3. The tender is allowed to submit the bid from the date of publishing till **03.00 PM on 24.01.2025**. The **Technical Bid (Part-I)** of the tender will be opened on the same day *i.e.*, on **24.01.2025 at 04.00 PM and** price bid will be opened on **27.01.2025 at 04.00 PM** in the Office of Addl.G.M (Forestry), Kothagudem Corporate.
4. The bidder shall scan and upload all the required documents / certificates/ statements. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.

5. Technical bid will be opened on the due date. The price bid of only those tenderer, who are found qualified in technical bid will be opened after technical evaluation of the bid is completed. The date of opening of price bid mentioned is only indicative date. In case of any extension of last date for submission of bid / date of opening of technical bid, suitable corrigendum will be released in the e-procurement platform.
6. The Earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalization of the L1 tenderer.
7. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
8. The Company employees should not participate in tenders either directly or indirectly.
9. The proposed quantity in the estimate are only tentative, they may increase or decrease subject to field requirement.
10. Before participation in the tender, the bidders are advised to go through the NIT, Terms & Conditions, Estimate thoroughly. Bidders shall quote in the online format as **AT PAR** with estimated value (**Unit Rate system**). The successful bidder will be finalized among the qualified bidder by drawing a lottery.
11. The wages are to be paid directly to the workers through a bank account.
12. A uniform penalty of Rs.300/- will be imposed towards absenteeism of each man day (irrespective of number of days of absence).
13. **Employment of local persons:**
  - i) The successful bidder shall employ the local persons not less than 80% for unskilled category of work.
  - ii) The successful bidder shall also give preference to local persons in skilled category and shall employ as many as possible.
  - iii) Local persons means persons from PDFs, PAFs and persons belongings to local area where coal mining operations are being carried on or shall be carried on in future.
  - iv) First preference for employment shall be given to Project Displaced Families (PDFs) & Project Affected Families (PAFs) and then to other local persons.
14. Though registration certificate is shown as mandatory in documents required screen. The same is not applicable for this work.
15. Though possessing of turnover, liquid assets/ Credit facilities is shown in the as mandatory in eligibility criteria screen. The same is not applicable for this work also the parameters.

16. In the PQ stage, the bidders need not submit data for following parameters in the given format.
  - a. Key critical equipment
  - b. Previously executed works
  - c. Work done as a prime contractor
  - d. Key personnel
  - e. Works on hand / Tendered details
  - f. Eligibility criteria.
