1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD. In price bid, the bidders should quote their uniform percentage on the estimated value of the work. The **Price Bids (Part-II)** of the bidders who qualify in the Technical Evaluation only will be considered, and accepted to open, on approval of competent authority.
2. Experienced bidders should participate by uploading relevant documents in e-portal along with the EMD as mentioned shall be paid online or by Challan generation through any Nationalized bank in favour of **The Singareni Collieries Company Limited, Srirampur**. The EMD submitted shall be valid for the entire period of the contract from the date of opening of the tender.
3. The tenders are allowed to submit the bids from the date of publishing the tender notice till **03:30 PM on 12.06.2025**. The **Technical Bid (Part-I)** of the tender will be opened on the same day i.e., on **12.06.2025 at 04:00 PM**.

4. The bidder shall scan and upload all the required documents / certificates/ statements / EMD instruments. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.
  - a) **Proof of Earnest Money Deposit(EMD)** paid while participating in the tender.
  - b) **Proof of Experience:** Any agency who intends to participate in the tender should have done Eucalyptus clonal plantation/ Miscellaneous plantation anywhere in a minimum of 5 Ha area in previous years.
5. Technical bid will be opened on the due date. The price bid of only those tenderers, who are found qualified in technical bid will be opened after technical evaluation of the bids is completed. The dates of opening of price bid mentioned are only indicative date. In case of any extension of last date for submission of bids / date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform. The Earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalization of the L1 tenderer. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
6. The Earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalization of the L1 tenderer.
7. The company reserves the right to cancel/withdraw whole or part of the above mentioned works without assigning any reason what so ever.
8. The Company employees should not participate in tenders either directly or indirectly.
9. The proposed quantity in the estimate are only tentative, they may increase or decrease subject to field requirement.
10. Before quoting the rates, the bidders are advised to go through the NIT, Terms & Conditions, Estimate thoroughly. Bidders shall quote their rate in the online format and shall not quote more than plus or minus 10%.
11. In case, more than one lowest tenderer quote the similar discount rate up to 10%, the work will be awarded by drawing the lottery among such tenderers.
12. **Employment of local persons:**
  - i) The successful bidder shall employ the local persons not less than 80% for unskilled category of work.
  - ii) The successful bidder shall also give preference to local persons in skilled category and shall employ as many as possible.
  - iii) Local persons means persons from PDFs, PAFs and persons belonging to local area where coal mining operations are being carried on or shall be carried on in future.
  - iv) First preference for employment shall be given to Project Displaced Families (PDFs) & Project Affected Families (PAFs) and then to other local persons.
13. Though registration certificate is shown as mandatory in documents required screen. The same is not applicable for this work.



14. Though possessing of turnover, liquid assets/ Credit facilities is shown in the as mandatory in eligibility criteria screen, the same is not applicable for this work, also the parameters.
15. In the PQ stage, the following parameters also not applicable for this work

  - Work done as a prime contractor
  - Key personnel
  - Works on hand / Tendered details

21. **All the contract workmen shall follow SOPs(Standard Operating Procedures) while planting on the OB dumps and also it is mandatory that each contract workman should undergo IME/PME and in VTC training before utilized in the planting activity.**
22. **Incidental charges like transportation of labour, supply of personal protection equipment (PPE) to contract workers etc. shall be borne by the agency.**
