Tenders are invited by the undersigned from the **experienced Forestry contractors** for the following forestry works in Srirampur area during 2026-28 in **e-procurement mode (2 cover system)**.

<b>Contract Period</b> :From the date of commencement to 31.03.2028			

1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD/MSME certificate and experience certificate of forestry works in the preceding 10 years (including current financial year). In price bid, the bidders should quote their uniform percentage on the estimated value of the work. The **Price Bids (Part-II)** of the bidders who qualify in the Technical Evaluation only will be considered for price bid evaluation on approval of competent authority.
2. Interested bidders should participate by uploading relevant documents in e-portal along with the EMD as mentioned shall be paid online or by Challan generation through any Nationalized bank in favour of The Singareni Collieries Company Limited, Srirampur. The EMD submitted shall be valid for the entire period of the contract from the date of opening of the tender.

3. **Exemption of EMD:** Exemption of EMD will be allowed for the agencies registered under MSME under specific classification codes related to Afforestation activities for participation in the forestry tenders. However, if the MSME registered agency/contractor exempted from the payment of initial EMD happened to be successful bidder, he has to submit total EMD at the time of executing the agreement, which will be converted into Security deposit. The additional security deposit applicable for discounted tenders as per the approved Forestry Manual shall also be collected from the successful bidder before entering into agreement. The bidder exempted from submission of EMD shall upload the scanned copy of documents online in support of exemption, during bid submission; otherwise the offer is liable for rejection. In case, the specified MSME codes are not registered, then the exemption will not be applicable, hence, EMD has to be paid while participating in the tenders.
4. **Eligibility criteria for participation in tenders:** As per circular No: CRP/FTY/A/2026/529, dt.25.05.2026, bidders are required to have a minimum financial turnover prescribed in Forestry works carried out by him in any one financial year in the preceding 10 years (including current financial year). Requirement of minimum financial turnover shall be arrived at as per the formula:  $0.5 \times (12/N) \times ECV$ , Where N is the time period given for completion of the work in months. If time period given is up to 6 months N shall be taken as 6 and if time period is above 6 and below 12 months, it shall be taken as 12. **ECV is Estimated Contract Value.**
5. The tenders are allowed to submit the bids from the date of publishing the tender notice till **03:00 PM on 07.07.2026**. The **Technical Bid (Part-I)** of the tender will be opened on the same day *i.e.*, on **07.07.2026 at 04:00 PM** and the price bid will be opened on 09.07.2026 at 04.00 PM in the Office of DGM (Forestry), Srirampur area.
6. The bidder shall scan and upload all the required documents / certificates/ statements / EMD instruments. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.
7. Technical bid will be opened on the due date. The price bid of only those tenderers, who are found qualified in technical bid will be opened after technical evaluation of the bids is completed. The dates of opening of price bid mentioned are only indicative date. In case of any extension of last date for submission of bids / date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform.
8. The Earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalization of the L1 tenderer.
9. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
10. The Company employees should not participate in tenders either directly or indirectly.
11. The proposed quantity in the estimate are only tentative, they may increase or decrease subject to field requirement.
12. Before quoting the rates, the bidders are advised to go through the NIT, Terms & Conditions, Estimate thoroughly. Bidders shall quote their rate in the online format and shall not quote less than minus 10%.
13. In case, more than one lowest tenderer quote the similar discount rate up to 10%, the work will be awarded by drawing the lottery among such tenderers.

14. As per clause 3.2 of Terms and conditions of Forestry Manual, the agency who quotes discount tender (Minus side) above 5% and up to 10% the agency has to enclose /upload the copies of certificate of previous experience of carried out similar work of similar magnitude in any of the Government Dept./public sectors undertakings/ reputed private firms.

**15. Employment of local persons:**

- i) The successful bidder shall employ the local persons not less than 80% for unskilled category of work.
- ii) The successful bidder shall also give preference to local persons in skilled category and shall employ as many as possible.
- iii) Local persons means persons from PDFs, PAFs and persons belongings to local area where coal mining operations are being carried on or shall be carried on in future.
- iv) First preference for employment shall be given to Project Displaced Families (PDFs) & Project Affected Families (PAFs) and then to other local persons

16. Though registration certificate is shown as mandatory in documents required screen. The same is not applicable for this work.

17. Though possessing of turnover, liquid assets/ Credit facilities is shown in the as mandatory in eligibility criteria screen, the same is not applicable for this work, also the parameters.

18. In the PQ stage, the following parameters also not applicable for this work

- a. Key critical equipment
- b. Previously executed works
- c. Work done as a prime contractor
- d. Key personnel
- e. Works on hand / Tendered details
- f. Eligibility criteria.

20. The Conditional tenders will not be accepted.

21. The intending tenderers are advised to inspect the areas personally before participating in the tenders.

22. All the taxes will be borne by the bidder like viz; GST, IT etc., from time to time as applicable.

23. Notwithstanding to anything stated above, The Singareni Collieries Company Limited reserves them to assess the capability and capacity of intending tenderers to perform the contract.

24. **Special condition for OB plantation works: All the contract workmen shall follow SOPs(Standard Operating Procedures) while planting on the OB dumps and also it is mandatory that each contract workman should undergo IME/PME and in VTC training before utilized in the planting activity.**
25. **Special condition for OB plantation works: Incidental charges like transportation of labour, supply of personal protection equipment (PPE) to contract workers etc. shall be borne by the agency.**
26. The General Terms and conditions furnished in the tender will be applicable, where ever if is deemed fit for the works specified.
