1. The tender shall be two parts namely Technical bid and Price bid. Technical bid shall contain documents support of EMD. In price bid, the rate will be **at par with estimated rates only** and tenderer should confirm their acceptance on SCCL tender schedule. **Please quote AT PAR only, the agencies quoted less/more than the estimated rates will be rejected and not considered for the lottery.** The **Price Bids (Part-II)** of the bidders who qualify in the Technical Evaluation only will be considered, and accepted to open, on approval of competent authority.
2. Interested bidders should participate in e-portal along with the EMD as mentioned shall be paid online or by Challan generation through any Nationalized bank in favour of The Singareni Collieries Company Limited, Srirampur. The EMD submitted shall be valid for the entire period of the contract from the date of opening of the tender.
3. The tenders are allowed to submit the bids up to **3.00 PM on 11.11.2025**. The **Technical Bid (Part-I)** of the tender will be opened on the same day i.e, on **11.11.2025 at 4.00 PM**
4. The bidder shall scan and upload all the required documents / certificates/ statements if any. The bidder is liable to be disqualified and blacklisted, if false information is furnished in the forms/ certificates/ statements submitted in proof of qualification requirements and misled the company.
5. Technical bid will be opened on the due date. The price bid of only those tenderers, who are found qualified in technical bid will be opened after technical evaluation of the bids is completed. In case of any extension of last date for submission of bids / date of opening of technical bids, suitable corrigendum will be released in the e-procurement platform
6. **Lottery will be drawn among the tenderers whose offers are technically acceptable under Unit rate Lottery system and the winner will be declared as successful tenderer.**
7. The Earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalization of the L1 tenderer.
8. In case of successful tenderer, in addition to the EMD paid, the successful tenderer has to pay the Security deposit amount @ 8 % of the tender value and the same will be deducted from the running bills.
9. The Company reserves the right to cancel/ withdraw whole or part of the above mentioned works without assigning any reason what so ever.
10. The Company employees should not participate in tenders either directly or indirectly.

12. Before quoting the rates, the bidders are advised to go through the NIT, Terms & Conditions, Estimate thoroughly.
13. The wages are to be paid directly to the workers through bank account.
14. **Uniform penalty to the absenteeism @ Rs.300/- per each man day will be deducted from payments of the agency.**
15. **Employment of local persons:**
 - i) The successful bidder shall employ the local persons not less than 80% for unskilled category of work.
 - ii) The successful bidder shall also give preference to local persons in skilled category and shall employ as many as possible.
 - iii) Local persons means persons from PDFs, PAFs and persons belonging to local area where coal mining operations are being carried on or shall be carried on in future.
 - iv) First preference for employment shall be given to Project Displaced Families (PDFs) & Project Affected Families (PAFs) and then to other local persons
16. IME/PME as required under mines Act, 1950 & Mines rule, 1955 shall be conducted at free of cost in all SCCL hospitals to all outsourced contractor's employees.
17. Though registration certificate is shown as mandatory in documents required screen. The same is not applicable for this work.
18. Though possessing of turnover, liquid assets/ Credit facilities is shown in the as mandatory in eligibility criteria screen. The same is not applicable for this work also the parameters.
19. In the PQ stage, the following parameters also not applicable for this work

 - b. Previously executed works
 - c. Work done as a prime contractor
 - d. Key personnel
 - e. Works on hand / Tendered details
