#### General Details about STPP, Jaipur, SCCL, :

Singareni collieries company Limited (SCCL) is a Government Company jointly owned by Government of Telangana and Government of India on 51:49 equity basis. The company mainly engaged in mining of coal. As part of diversification, the company has entered into power generation and presently operating 2X600MW Singareni thermal power plant (STPP), located at Mancherial district of Telangana State.

To utilize the Fly ash from pond at STPP in gainful and sustainable manner as per the provisions of extant MOEF&CC Gazette Notification and promote utilization of Fly ash from pond as resource material, SCCL intends to issue un-utilized Fly ash from pond quantity left after e-auction on 'free of cost', 'first come first serve' and 'as is where is' basis, with loading and transportation cost to be borne by the User agency.

In compliance to extant guidelines issued by Ministry of Power, Govt. of India; SCCL invites Expressions of Interest (EOI) for disposal of un-utilized Fly ash from pond quantity from it's Ash pond. The details regarding the Expression of Interest are as follows:

#### Allocation of Fly ash from pond Quantity:

Based on the time of receipt of responses to EOI, fly ash from pond shall be allocated to Firms on free of cost on "as is where is basis" and on 'first come, first serve' basis, till the available offered quantity is exhausted. However, lifting of Fly ash from pond from STPP Ash Pond and transportation to their locations thereafter will be in the scope of the Firm only. Firm gets some allocation against e- Auction Process as well as through this Ash quantity allocated against this EOI shall be issued to that Firm, only after the Firm completes the lifting of the total allocation against the e-Auction Process.

In case, the allocated quantity is totally lifted by firm, additional quantity may be allotted by SCCL if available with approval of ED/HoP, STPP.

Duration of issue of fly ash from pond is for a period of 7 months (Extendable as decided by EIC on mutual agreement on availability).

In case of non-mobilization / inadequate mobilization, SCCL may, at its discretion, allocate such quantity to alternate firm (s) / avenue(s). Decision of ED/HoP, STPP, shall be final and binding in this regard.

Fly ash from pond shall be issued on 'as is where is' basis from designated storage areas in Ash pond as decided by the Engineer In Charge (EIC), Ash Utilisation Group, STPP.

#### Part 4: Terms and Conditions and General Guidelines:

- Fly ash from pond shall be issued from the designated storage area or other location as decided by EIC to the Successful Firms (or their authorized representatives as may be agreed to in writing by the EIC), considering Operational and Safety issues.
- 2. Firms shall make themselves aware of the various extant Rules, Procedures, Safety norms, Environmental and Sustainability Guidelines etc and carry out their activities in full compliance with the same.
- 3. No person / agency shall be allowed to lift ash without due permission from authorized officials of STPP.
- 4. Agencies eligible for lifting Fly ash from pond shall apply for permission for the covered/closed trucks that they propose to deploy and submit the same to E C along with specified documents like registration, license, insurance etc, who shall arrange to verify the same and issue permission as per prevailing procedure adopted at the Station.
- 5. Depending upon operational convenience, safety, etc. EIC can schedule or reschedule the lifting of ash by different agencies, which shall be binding upon the agencies. Agencies shall start collecting the Ash as per their respective allocation as per the schedule intimated by the EIC.
- 6. Statutory/ regulatory compliances shall be binding upon all the agencies and verifiable by STPP.
- 7. Non compliance shall attract penal actions ranging from fine to termination of contract / agreement / issue of Fly ash from pond as decided by EIC.
- 8. Transportation of Ash shall be in the Scope of the Successful Firm(s).
- 9. Road Permits, Operator / Driver Licenses, Insurance etc. for the deployed Vehicles shall be submitted at the time of start of work (and also when new and / or additional vehicles are deployed) and thereafter as and when demanded by the EIC for verification. The vehicles shall be in fit condition for safe operation.
- 10. The Firm shall submit an affidavit on Non judicial stamp paper of requisite value, certifying the complete Utilization of issued Fly ash from pond, in adherence with the provisions of the extant Notification and other applicable statutory regulations. This affidavit, in prescribed format, shall be submitted on Half Yearly basis to the EIC.
- 11. In case of any liability on TPP, in any manner that arises due to non-compliance of any Environmental and Transportation Norms, Rules, Guidelines and Statutory provisions by the successful Firm or its representative / agent, during the course of execution and for future obligations (if any) by way of omission or commission, the Successful Firm shall keep TPP effectively indemnified of any such liability. The FLY ASH USER hereby agrees that OWNER shall not be held responsible in any way, either legally or financially for any accidents caused to the laborers, transporters, drivers & cleaners being engaged by FLY ASH USER, peroperty/ employees of OWNER & also caused to any third party, either within or outside the OWNER factory premises. In case of happening of any such events, no liability, whatsoever, shall be fastened on OWNER and we undertake to indemnify and keep indemnified OWNER against all such claims that may be brought against OWNER for such incidents.

In the event of occurrence of such incident as mentioned at SI. No. 1 above, the FLY ASH 2.
